Bids for furnishing all labor, equipment (excluding submersible well pump and appurtenances, as noted below), materials necessary to drill, install, and equip one (1) test slant well (Schedule 1) and twelve (12) monitoring wells (Schedule 2) that are part of the Monterey Peninsula Water Supply Project (MPWSP) - Test Slant Well Project. A second bid package (Civil Construction Package) which includes site grading, well vault installation, instrumentation and controls, electical conduit, and discharge piping will be separately procured. Bidder shall include installation of owner furnished well as an appurtenances.

Bids for performing all work to construct the MPV 3P Schedule I Sest Slant Well), or Schedule 2 (Monitoring Wells), or both Schedules 1 and Schall se received by e-mail to Ian Crooks (ian.crooks@amwater.com), Engineering Manager at Canara American Water (Coastal Division). All e-mail bids must be submitted by 2:00 p.m., local sime, Augus X, 2014. Each Bid must contain evidence of Bidder's qualification to do business as a Class All General Engineering Contractor per California Business & Professions Code Division 3, Chapter 9. Contractor Ancle 4.

Two (2) sets of Bidding Documers, including the Instructions to Bidders, Bid Form, Bid Bond Forms and Contract Documents, will be provided at the CONTRACTORS who are invited to bid the project. Additional copies can be obtained from California American Water, 511 Forest Lodge Road, Suite 100, Pacific Grove, CA 9395, for the cut of a roduction. Subcontractors, manufacturers, and material suppliers should obtain information and review the Bidding Documents by contacting potential Bidders.

OWNER reserves its rights to waive any informality or deficiency in any Bid, to accept any Bid, to negotiate modifications of any Bid with any Bidder and accept any modified Bid, to reject any Bid, to reject all Bids, and to rebid the Project, all at the OWNER's sole discretion.

INSTRUCTIONS TO BIDDERS

1. Defined Terms

Terms used in these Instructions to Bidders which are defined in the General Conditions of the Contract Documents have the meanings assigned to them in the General Conditions. The term "Bidder" means one who submits a Bid directly to OWNER, as distinct from a subbidder, who submits a Bid to a Bidder. The term "Successful Bidder" means the lowest, qualified, responsible and responsive Bidder to whom OWNER (on the basis of OWNER's evaluation as hereinafter provided) makes an award. The term "Bidding Documents" includes the Invitation to Bid, Instructions to Bidders, the Bid Form, and the proposed Contract Documents (including all Addenda issued prior to receipt of Bids).

2. Copies of Bidding Documents

- 2.1 Complete sets of the Bidding Documents in the number and for the amount, if any, stated in the Invitation to Bid may be obtained from the party listed on the Invitation to Bid No refunds will be made for the return of complete or partial copies of the Bidding Documents.
- 2.2 Complete sets of Bidding Documents must be used in preparing Bids; wither OWNER nor ENGINEER assume any responsibility for errors or misinterpretation desulting from the use of incomplete sets of Bidding Documents.
- 2.3 OWNER and ENGINEER in making copil and Bidding A suments available on the above terms do so only for the purpose of obtaining Bids on the Wol and count comer a license or grant for any other use.

3. Qualifications of Bidders

Bidders must be prequalified. Eac Bid protection evidence of Bidder's qualification to do business in the state where the project is located or calculate to obtain such qualification prior to award of the contract.

4. Examination of contract Lecunit s and Site

- 4.1 It is the responsibility of each Folder before submitting a Bid, to (a) examine the Contract Documents thoroughly, (b) visit the state of come familiar with local conditions that may affect cost, progress, performance or furnishing of the Work, (c) consider Laws and Regulations that may affect cost, progress, performance or furnishing of the Work, (d) study and carefully correlate Bidder's observations with the Contract Documents, and (e) notify ENGINEER of all conflicts, errors or discrepancies in the Contract Documents.
- 4.2 Reference is made to Exhibits for identification of:
- 4.2.1 those reports of explorations and tests of subsurface conditions at the site which have been utilized by ENGINEER in preparation of the Contract Documents. Bidder may rely upon the accuracy of the technical data contained in such reports but not upon non-technical data, interpretations or opinions contained therein or for the completeness thereof for the purposes of bidding or construction.
- 4.2.2 those drawings of physical conditions in or relating to existing surface and subsurface conditions (except Underground Facilities) which are at or contiguous to the site which have been utilized by ENGINEER in preparation of the Contract Documents. Bidder may rely upon the accuracy of the technical data contained in

such drawings but not upon non-technical data, interpretations or opinions contained therein or for the completeness thereof for the purpose of bidding or construction.

Copies of such reports and drawings will be made available by OWNER to any Bidder on request. Those reports and drawings are not part of the Contract Documents.

- 4.3 Information and data reflected in the Contract Documents with respect to Underground Facilities at or contiguous to the site is based upon information and data furnished to OWNER and ENGINEER by owners of such Underground Facilities or others, and OWNER does not assume responsibility for the accuracy or completeness thereof unless it is expressly provided otherwise in the General Conditions..
- 4.4 Provisions concerning responsibilities for the adequacy of data furnished to prospective Bidders on subsurface conditions, Underground Facilities and other physical conditions, and possible changes in the Contract Documents due to differing conditions appear in Article 4 of the General Conditions.
- 4.5 Before submitting a Bid, each Bidder will, at Bidder's own expense, make or obtain any additional examinations, investigations, explorations, tests and studies and of an any additional information and data which pertain to the physical conditions (surface, subsurface are Undergound Facilities) at or contiguous to the site or otherwise which may affect cost, progress, performance or furnishing of the Work and which Bidder deems necessary to determine its Bid for performing and arnishing the Work in accordance with the time, price and other terms and conditions of the Contract Dominents.
- 4.6 On request in advance and after submittal of Bidder's vidence of insurance coverage meeting limits designated in Exhibit Q, OWNER will provide a splidder accept to the site to conduct such explorations and tests as each Bidder deems necessary for submission of the Splidder shall fill all holes, clean up and restore the site to its former condition upon completion of the explorations.
- 4.7 The lands upon which the Wo is to b ed, rights-of-way and easements for access thereto and perfor other lands designated for use b performing the Work are identified in the Contract CONT Documents. All additional lands and ss thereto required for temporary construction facilities or storage of materials and equipment ded by CONTRACTOR. Easements for permanent structures or se to be obtained and paid for by OWNER unless otherwise permanent changes in sting str provided in the Contrac Pocuments.
- 4.8 The submission of a be will constitute an incontrovertible representation by Bidder that Bidder has complied with every requirement that without exception the Bid is premised upon performing and furnishing the Work required by the Contract Documents and such means, methods, techniques, sequences or procedures of construction as may be indicated in or required by the Contract Documents, and that the Contract Documents are sufficient in scope and detail to indicate and convey understanding of all terms and conditions for performance and furnishing of the Work.

5. Interpretations and Addenda

5.1 All questions about the meaning or intent of the Contract Documents are to be directed to ENGINEER. Interpretations or clarifications considered necessary by ENGINEER in response to such questions will be issued by Addenda mailed or delivered to all parties recorded by ENGINEER as having received the Bidding Documents. Questions received less than ten days prior to the date for opening of Bids may not be answered. Only questions answered by formal written Addenda will be binding. Oral and other interpretations or clarifications will be without legal effect.

5.2 Addenda may also be issued to modify the Bidding Documents as deemed advisable by OWNER or ENGINEER

6. Bid Security

- 6.1 Each Bid must be accompanied by Bid security made payable to OWNER in an amount of ten percent of the Bidder's maximum Bid price and in the form of a Bid Bond (on form attached), issued by a surety meeting the requirements of Article 5 of the General Conditions.
- 6.2 The Bid security of the Successful Bidder will be retained until such Bidder has executed the Agreement and furnished the required contract security, whereupon the Bid security will be returned. If the Successful Bidder fails to execute and deliver the Agreement and furnish the required contract security within fifteen days after the Notice of Award, OWNER may annul the Notice of Award and the Bid security of that Bidder will be forfeited. The Bid security of other Bidders whom OWNER believes to have a reasonable chance of receiving the award may be retained by OWNER until the expiration of the period that bids are subject to acceptance, whereupon Bid security furnished by such Bidders will be returned. Bid security with Bids which are not competitive will be returned within Fourteen days after the Bid open.

7. Contract Times

The times for Substantial Completion and Final Completion are to e set forth in the Agreement.

8. Liquidated Damages

Provisions for liquidated damages, if any, are set 1 orth in Agreement

9. Substitute and "Or-Equal" Vans

Substitute or "Or-Equal" items are bject to a suitements of Article 6.5 of the General Conditions.

All Bids shall be based upgrant ecific products. However, Bidders are encouraged to quote on alternative products by listing therein the tablation of "Alternative Equipment and/or Materials" of the Bid Form as required by Section 1, 0 of the G eral Requirements. No later substitutes will be considered by the OWNER.

The specified products have be a used in preparing the Drawings and Specifications and thus establish minimum qualities which alternatives must meet to be considered acceptable. The burden of proof of equality rests with the Bidder and adequate supporting information must be provided. The OWNER reserves the right to accept or reject proposed alternatives.

The Bid sum for each proposed alternative shall include all money required to incorporate the alternative into the project. Later requests for additional monies for alternatives will not be considered.

10. Subcontractors, Suppliers and Others

10.1 If the Exhibits require the identity of certain Subcontractors, Suppliers and other persons and organizations (including those who are to furnish the principal items of material and equipment) to be submitted to OWNER in advance of the specified date prior to the Effective Date of the Agreement, the apparent Successful Bidder, and any other Bidder so requested, shall within seven days after the Bid opening submit to OWNER a list of all such Subcontractors, Suppliers and other persons and organizations proposed for those portions of the Work for which such identification is required. Such list shall be accompanied by an

experience statement with pertinent organization information if requested by OWNER. If OWNER or ENGINEER after due investigation has reasonable objection to any proposed Subcontractor, Supplier, other person or organization, OWNER or ENGINEER may before the Notice of Award is given request the apparent Successful Bidder to submit an acceptable substitute without an increase in Bid price.

If apparent Successful Bidder declines to make any such substitution, OWNER may award the contract to the next lowest Bidder that proposes to use acceptable Subcontractors, Suppliers and other persons and organizations. The declining to make requested substitutions will not constitute grounds for sacrificing the Bid security of any Bidder. Any Subcontractor, Supplier, other person or organization listed and to whom OWNER or ENGINEER does not make written objection prior to the giving of the Notice of Award will be deemed acceptable to OWNER and ENGINEER subject to revocation of such acceptance after the Effective Date of the Agreement as provided in Paragraph 6.8.2 of the General Conditions.

10.2 No CONTRACTOR shall be required to employ any Subcontractor, Supplier, other person or organization against whom CONTRACTOR has reasonable objection.

11. Bid Form

- 11.1 The Bid Form is included with the Bidding Documents: Aditional codies may be obtained from the party issuing the documents as listed on the Invitation to Bid.
- 11.2 All blanks on the Bid Form must be completed in interactive typewriter.
- 11.3 Bids by corporations must be executed if the sorporate time by the president or a vice-president (or other corporate officer accompanied by evidence of automorphic to sign) and the corporate seal must be affixed and attested by the secretary or an assistant secret varieties and state of incorporation must be shown below the signature.
- 11.4 Bids by partnerships must be executed the partnership name and signed by a partner, whose title must appear under the signature and the one address of the partnership must be shown below the signature.
- 11.5 All names must be ped or photed be with signature.
- 11.6 The Bid shall contain an acknowledgement of receipt of all Addenda (the numbers of which must be filled in on the Bid Form).
- 11.7 The address and telephone number for communications regarding the Bid must be shown.

12. Submission of Bids

Bids shall be submitted at the time and place indicated in the **Invitation to Bid** and shall be enclosed in an opaque sealed envelope, marked with the Project title and name and address of the Bidder and accompanied by the Bid security and other required documents. If the Bid is sent through the mail or other delivery system the sealed envelope shall be enclosed in a separate envelope with the notation "BID ENCLOSED" on the face of it.

13. Modification and Withdrawal of Bids

Bids may be modified or withdrawn by an appropriate document duly executed (in the manner that a Bid must be executed) and delivered to the place where Bids are to be submitted at any time prior to the opening of Bids.

14. Opening of Bids

The opening of Bids will be **private**.

15. Bids to Remain Subject to Acceptance

All Bids will remain subject to acceptance for <u>75</u> days after the day of the Bid opening, but OWNER may, in its sole discretion, release any Bid and return the Bid security prior to the acceptance period.

16. Award of Contract

- 16.1 OWNER reserves the right to reject any and all Bids, to waive any and all informalities and to negotiate contract terms with the Successful Bidder, and the right to disregard all nonconforming, nonresponsive, unbalanced or conditional Bids. Also, OWNER reserves the right to reject the Bid of any Bidder if OWNER believes that it would not be in the best interest of the Project to rake an award to that Bidder, whether because the Bid is not responsive or the Bidder is unqualified or a publiful financial ability or fails to meet any other pertinent standard or criteria established by OWNER. Ascre, racies in the multiplication of units of Work and Unit Prices will be resolved in favor of the Unit Prices. Discrepancies between the indicated sum of any column of figures and the correct sum thereof will be resolved in favor of the correct sum.
- 16.2 In evaluating Bids, OWNER will consider the question of the Bidders, whether or not the Bids comply with the prescribed requirements, and such alternates. Unit Prices and other data, as may be requested in the Bid Form or prior to the Notice of Award.
- 16.3 OWNER may consider the qualifications and we hence of Subcontractors, Suppliers, and other persons and organizations proposed for those posterns of the Work as to which the identity of Subcontractors, Suppliers, and other persons and organizations must be submitted as provided in the Exhibits. OWNER also may consider the operating costs, suintended and submitted prior to the Notice of Awar.
- 16.4 OWNER may collect such investigations as OWNER deems necessary to assist in the evaluation of any Bid and to establish the responsibility qualifications and financial ability of Bidders, proposed Subcontractors, Suppliers and other persons and aganizations to perform and furnish the Work in accordance with the Contract Documents to OWNER satisfaction within the prescribed time.
- 16.5 If the contract is to be awarded, it will be awarded to the lowest Bidder whose evaluation by OWNER indicates to OWNER that the award will be in the best interests of the Project.
- 16.6 If the contract is to be awarded, OWNER will give the Successful Bidder a Notice of Award within the period of time that bids are subject to acceptance.

17. Contract Security

Article 5 of the General Conditions and Exhibits set forth OWNER's requirements as to performance, payment or other Bonds. When the Successful Bidder delivers the executed Agreement to OWNER, it must be accompanied by the required Bonds.

18. Signing of Agreement

When OWNER gives a Notice of Award to the Successful Bidder, it will be accompanied by the required number of unsigned counterparts of the Agreement with all other written Contract Documents attached. Within fifteen days thereafter CONTRACTOR shall sign and deliver the required number of counterparts of the Agreement and attached documents to OWNER with the required Bonds. Within ten days thereafter OWNER shall deliver one fully signed counterpart to CONTRACTOR.

19. Pre-Bid Meeting

Refer to **Invitation to Bid** for Pre-Bid Meeting requirements. If held, representatives of OWNER and ENGINEER will be present to discuss the Project. The **Invitation to Bid** sets forth Bidder attendance and participation requirements for the meeting. ENGINEER will transmit to all prospective Bidders of record such Addenda as ENGINEER considers necessary in response to questions arising at the meeting.

20. Taxes

Refer to Article 6.10 of the General Condition for information coverns, taxes.

21. Retainage



AGREEMENT

This Agreement is by and between California-American Water Company, a California Corporation (Owner), and ("Contractor").

Owner and Contractor hereby agree as follows:



ARTICLE 1 – WORK

- 1.01 Contractor shall complete all Work as specified or indicated in the Contract Documents. The Work is generally described as follows:
- Schedule 1: Dual-Rotary Drill (1,000 feet), install, and equip one (1) 760 linear foot slant well with a submersible pump as specified in the technical specifications (submersible well pump and appurtenances to be furnished by OWNER).
- Schedule 2: Sonic Drill (90 330 feet), install, and equip twelve (12) monitoring wells (4 clusters of 3 wells), as specified in the technical specifications.

ARTICLE 2 – THE PROJECT

2.01 The Project for which the Work under the Contract Documents may be the whole or only a part is generally described as follows:

The above scope of work to drill, install, and equip the test cant well (Schedule 1) and monitoring wells (Schedule 2) is one (1) of two (2) of astruction oid packages that are part of the Monterey Peninsula Water Supply Project (APWSP) - Test cant Well Project. The second bid package is the Civil Construction Reckage which includes site grading, well vault installation, instrumentation and controls, the call conduit, and discharge piping.

ARTICLE 3 – ENGINEER

- 3.01 The Engineer for the Projectic lan oks, Engineering Manager (CAW Coastal Division) who will act as the Owner's representative, assume all duties and responsibilities, and have the rights and athority assigned to Engineer in the Contract Documents in connection with the Contract Documents.
- 3.02 The following Owner-afficied entities or independent engineers, consultants, or managers have been retailed by Owner to undertake some or all of Engineer's or Owner's authoric duties, or responsibilities under the Contract Documents:

RBF Consulting, a company of Michael Baker Intl. is the owners agent and civil design team for the MPWSP Test Slant Well Project. GEOSCIENCE Support Services Inc. is the slant well and monirtoing well design team.

ARTICLE 4 - CONTRACT TIMES

- 4.01 Time of the Essence
 - A. All time limits for Milestones, if any, Substantial Completion, and Final Completion and readiness for final payment as stated in the Contract Documents are of the essence of the Contract.

- 4.02 Days to Achieve Substantial Completion and Final Completion
 - A. The Work will be substantially completed within 133 days (October 13, 2014 to February 27, 2015), after the date when the Contract Times commence to run as provided in Paragraph 2.03 of the General Conditions, and completed and ready for final payment in accordance with Paragraph 14.07 of the General Conditions within 90 days after the date when the Contract Times commence to run.

4.03 Liquidated Damages

A. Contractor and Owner recognize that time is of the essence of this Agreement and that Owner will suffer financial loss if the Work is not completed within the times specified in Paragraph 4.02 above, plus any extensions thereof allowed in accordance with Article 12 of the General Conditions. The parties also recognize the delays, expense, and difficulties involved in proving in a legal or arbitration proceeding the actual loss suffered by Owner if the Work is not completed time. Accordingly, instead of e that as liquidated damages for requiring any such proof, Owner and Contractor ag delay (but not as a penalty), Contractor shall particle. er: (1) **\$1,000.00** for each day that expires after the time specified in Paragraph 4.02 Substantial Completion, or after the time specified in Paragraph 4.2 from completion and reading payment, or any extension the payment, or any extension thereof in accordance with Paragraph 12.02 of the General Conditions, until the Work is com and real for final payment.

ARTICLE 5 - CONTRACT PRICE

A. The Contract Price for all Work is **Inse Contract Price**, as further specified in Exhibit C, subject to any subsequences the contract Price is **Inse Contract Price**, as further specified in Exhibit C, subject to any subsequences the contract Price is a further specified in Exhibit C.

ARTICLE 6 - PAYMEN PROC DURY

- 6.01 Submittal and Recessing Payments

All such payments will be measured by the schedule of values established as provided in Paragraph 2.05.A of the General Conditions (and in the case of Unit Price Work based on the number of units completed) or, in the event there is no schedule of values, as provided in the General Requirements.

- B. Prior to Substantial Completion, progress payments will be made in an amount equal to **tt%** percent of Work completed (with the balance being retainage), but, in each case, less the aggregate of payments previously made and less such amounts as Engineer may determine or Owner may withhold, including but not limited to liquidated damages, in accordance with Paragraph 14.02 of the General Conditions.
- C. Upon Substantial Completion, Owner shall pay an amount sufficient to increase total payments to Contractor to tt00% percent of the Work completed, less such amounts as Engineer shall determine in accordance with Paragraph 14.02.B.5 of the General Conditions and less ttt00.00% percent of Owner's determination of the value of Work to be completed or corrected as shown on the tentative list of items to be completed or corrected attached to the certificate of Substantial Completion.
- D. All applications for progress payments shall be accompanied by a conditional lien release and, for payments after the first, an affidavit of payment.

6.03 Final Payment

- A. Upon final completion and acceptance of the Work in accordance with Paragraph 14.07 of the General Conditions, Owner shappy the remarker of the Contract Price, and any retained funds, as provided in sale Paragraph 14.07.
- B. An application for final payment shall be a smpanied by a conditional lien release and an affidavit of payment.

ARTICLE 7 - CONTRACTOR'S REPRESENTATIONS

- 7.01 To induce Owner to cater in this greement, Contractor makes the following representations:
 - A. Contractor has been iped and carefully studied the Contract Documents and the other related data dentified with a liding Documents.
 - B. Contractor he visited le Site and become familiar with and is satisfied as to the general, local, and Sit conditions that may affect cost, progress, and performance of the Work.
 - C. Contractor is familiar with and is satisfied as to all federal, state, and local Laws and Regulations that may affect cost, progress, and performance of the Work.
 - D. Contractor has carefully studied all reports of explorations and tests of subsurface conditions at or contiguous to the Site and all drawings of physical conditions in or relating to existing surface or subsurface structures at or contiguous to the Site (except Underground Facilities) which have been provided pursuant to Paragraph 4.02 of the General Conditions.
 - E. Contractor has considered the information known to Contractor, information and observations obtained from visits to the Site, information commonly known to contractors doing business in the locality of the Site, the Contract Documents, and the

reports and drawings identified in the Contract Documents and referred to in Paragraph 7.01.D above with respect to the effect of such information and observations on: (1) the cost, progress, and performance of the Work; (2) the means, methods, techniques, sequences, and procedures of construction to be employed by Contractor, including any specific means, methods, techniques, sequences, and procedures of construction expressly required by the Bidding Documents; and (3) Contractor's safety precautions and programs.

- F. Based on the information and observations referred to in Paragraph 7.01.E above, Contractor does not consider that further examinations, investigations, explorations, tests, studies, or data are necessary for the performance of the Work at the Contract Price, within the Contract Times, and in accordance with the other terms and conditions of the Contract Documents.
- G. Contractor is aware of the general nature of work to be performed by Owner and others at the Site that relates to the Work as indicated the Contract Documents.
- H. Contractor is prepared to comply with the applicable quirements of Owner's safety program, if any.
- I. Contractor has given Engineer written ruice of all conflicts, errors, ambiguities, or discrepancies that Contractor has discorred in the Contract Documents, and the written resolution thereof by Engineer is acceptable to Contractor.
- J. The Contract Documents are generally a fisient windicate and convey understanding of all terms and conditions for performance and currishing of the Work.
- K. If checked, Contractor will p vide wher with \(\subseteq \) a performance bond or \(\subseteq \) a payment bond, or any constitution thereof, as indicated in this Paragraph and conforming to the specific on sin and cle 5 of the General Conditions.

9.04 Severability

A. Any provision or part of the Contract Documents had to be void or unenforceable under any Law or Regulation shall be deemed striken, and all remaining provisions shall continue to be valid and binding upon Owns and Contractor, who agree that the Contract Documents shall be reformed to replace substricken provision or part thereof with a valid and enforceable provision that come has close as possible to expressing the intention of the stricken provision.

9.05 Contractor's Certifications

- A. Contractor certifies that it has not reged corrupt, fraudulent, collusive, or coercive practices in competing for or exacting the Contract. For the purposes of this Paragraph 9.05:

STANDARD GENERAL CONDITIONS OF THE CONSTRUCTION CONTRACT FOR CONSTRUCTION PROJECTS IN CALIFORNIA

ARTICLE 1 - DEFINITIONS AND TERMINOLOGY

1.01 Defined Terms

- A. Wherever used in the Bidding Requirements or Contract Documents and printed with initial capital letters, the terms listed below will have the meanings indicated which are applicable to both the singular and plural thereof. In addition to terms specifically defined, terms with initial capital letters in the Contract Document include references to identified articles and paragraphs, and the titles of other documents or contract Documents.
 - 1. Addenda Written or graphic instruments issued pric to the opening of Bids which clarify, correct, or change the Bidding Requirements or the proposed Contract Documents.
 - 2. Agreement The written instrument which is evidence of the agreement between Owner and Contractor covering to tark.
 - 3. Application for Payment The folial acceptable to Engineer which is to be used by Contractor during the course of the Work in requesting progress or final payments and which is to be accompared by a ch supporting documentation as is required by the Contract Documents.
 - 4. Asbestos P. y material that contains more than one percent asbestos and is friable or is releasing asbesto, fibers into the air above current action levels established by the United States Occurational Safety and Health Administration.
 - 5. *Bid* The offer of posal of a Bidder submitted on the prescribed form setting forth the prices for the Work to be performed.
 - 6. *Bidder* The individual or entity who submits a Bid directly to Owner.
 - 7. Bidding Documents The Bidding Requirements and the proposed Contract Documents (including all Addenda).
 - 8. Bidding Requirements The Advertisement or Invitation to Bid, Instructions to Bidders, bid security of acceptable form, if any, and the Bid Form with any supplements.

- 9. Change Order A document recommended by Engineer which is signed by Contractor and Owner and authorizes an addition, deletion, or revision in the Work or an adjustment in the Contract Price or the Contract Times, issued on or after the Effective Date of the Agreement.
- 10. Claim A demand or assertion by Owner or Contractor seeking an adjustment of Contract Price or Contract Times, or both, or other relief with respect to the terms of the Contract. A demand for money or services by a third party is not a Claim.
- 11. Contract The entire and integrated written agreement between the Owner and Contractor concerning the Work. The Contract supersedes prior negotiations, representations, or agreements, whether written or oral.
- 12. Contract Documents Those items so designated in the Agreement. Only printed or hard copies of the items listed in the Agreement are Contract Documents. Approved Shop Drawings, other Contractor's submittals, and the reports and drawings of subsurface and physical conditions are not Copie and Documents.
- 13. Contract Price The moneys payable by wher to Cutractor for completion of the Work in accordance with the Contract Documents as stated in the Agreement (subject to the provisions of Paragraph 103 the case of Unit Price Work).
- 14. Contract Times The number collays or the dates stated in the Agreement to: (i) achieve Milestones, if any, (ii) achieve substantial Completion; and (iii) complete the Work so that it is ready for find regiment as evidenced by Engineer's written recommendation of final cay cent.
- 15. Contractor The Stividus county with whom Owner has entered into the Agreement.
- 16. Cost of the ork Se Pars raph 11.01.A for definition.
- 17. Drawings That part of the Contract Documents prepared or approved by Engineer which graphicals shows the scope, extent, and character of the Work to be performed by Contractor. Shop Drawings and other Contractor submittals are not Drawings as so defined.
- 18. Effective Date of the Agreement The date indicated in the Agreement on which it becomes effective, but if no such date is indicated, it means the date on which the Agreement is signed and delivered by the last of the two parties to sign and deliver.
- 19. *Engineer* The individual or entity named as such in the Agreement.

- 20. Field Order A written order issued by Engineer which requires minor changes in the Work but which does not involve a change in the Contract Price or the Contract Times.
- 21. *General Requirements* Sections of Division 1 of the Specifications. The General Requirements pertain to all sections of the Specifications.
- 22. Hazardous Environmental Condition The presence at the Site of Asbestos, PCBs, Petroleum, Hazardous Waste, or Radioactive Material in such quantities or circumstances that may present a substantial danger to persons or property exposed thereto in connection with the Work.
- 23. Hazardous Waste The term Hazardous Waste shall have the meaning provided in Section 1004 of the Solid Waste Disposal Act (42 USC Section 6903) as amended from time to time.
- 24. Laws and Regulations; Laws or Regulations A v and all applicable laws, rules, regulations, ordinances, codes, and orders of any and all governmental bodies, agencies, authorities, and courts having jurisdiction.
- 25. Liens Charges, security interests, en ambrances upon Project funds, real property, or personal property.
- 26. *Milestone* A principal event specifically in the Contract Documents relating to an intermediate completion date or till a profit substantial Completion of all the Work.
- 27. Notice of Award The writte notice by Owner to the Successful Bidder stating that upon timely compliance by the Successful Bidder with the conditions precedent listed therein, Owner will sign and deliver the Agreement.
- 28. Notice to Proceed A written notice given by Owner to Contractor fixing the date on which the contract Times will commence to run and on which Contractor shall start to perform the Work upper the Contract Documents.
- 29. Owner The American Water System entity with which Contractor has entered into the Agreement and for which the Work is to be performed.
- 30. PCBs Polychlorinated biphenyls.
- 31. Petroleum Petroleum, including crude oil or any fraction thereof which is liquid at standard conditions of temperature and pressure (60 degrees Fahrenheit and 14.7 pounds per square inch absolute), such as oil, petroleum, fuel oil, oil sludge, oil refuse, gasoline, kerosene, and oil mixed with other non-Hazardous Waste and crude oils.

- 32. *Progress Schedule* A schedule, prepared and maintained by Contractor, describing the sequence and duration of the activities comprising the Contractor's plan to accomplish the Work within the Contract Times.
- 33. *Project* The total construction of which the Work to be performed under the Contract Documents may be the whole, or a part.
- 34. *Project Manual* The bound documentary information prepared for bidding and constructing the Work. A listing of the contents of the Project Manual, which may be bound in one or more volumes, is contained in the table(s) of contents.
- 35. Radioactive Material Source, special nuclear, or byproduct material as defined by the Atomic Energy Act of 1954 (42 USC Section 2011 et seq.) as amended from time to time.
- 36. Resident Project Representative The authorize representative of Engineer who may be assigned to the Site or any part thereof
- 37. Samples Physical examples of materics, equipment, or workmanship that are representative of some portion of the V ork and which establish the standards by which such portion of the Work will be larged.
- 38. Schedule of Submittals A schedule, prepared and maintained by Contractor, of required submittals and the time equation pents to support scheduled performance of related construction activities.
- 39. Schedule of Values schedule, propared and maintained by Contractor, allocating portions of the Contractor, to various portions of the Work and used as the basis for reviewing Contractor applications for Payment.
- 40. Shop Drawings All nawles, diagrams, illustrations, schedules, and other data or information, which are pecifically prepared or assembled by or for Contractor and submitted by antracto to illustrate some portion of the Work.
- 41. Site Lands or an as indicated in the Contract Documents as being furnished by Owner upon which the Work is to be performed, including rights-of-way and easements for access thereto, and such other lands furnished by Owner which are designated for the use of Contractor.
- 42. Specifications That part of the Contract Documents consisting of written requirements for materials, equipment, systems, standards and workmanship as applied to the Work, and certain administrative requirements and procedural matters applicable thereto.

- 43. Subcontractor An individual or entity having a direct contract with Contractor or with any other Subcontractor for the performance of a part of the Work at the Site.
- 44. Substantial Completion The time at which the Work (or a specified part thereof) has progressed to the point where, in the opinion of Engineer, the Work (or a specified part thereof) is sufficiently complete, in accordance with the Contract Documents, so that the Work (or a specified part thereof) can be utilized for the purposes for which it is intended. The terms "substantially complete" and "substantially completed" as applied to all or part of the Work refer to Substantial Completion thereof.
- 45. Successful Bidder The Bidder submitting a responsive Bid to whom Owner makes an award.
- 46. Supplementary Conditions That part of the Contract Documents which amends or supplements these General Conditions.
- 47. Supplier A manufacturer, fabricator, supplier a stributor, materialman, or vendor having a direct contract with Contractor or with any S bcontractor to furnish materials or equipment to be incorporated in the Work by Contractor or any Subcontractor.
- 48. Underground Facilities All underground piralines, conduits, ducts, cables, wires, manholes, vaults, tanks, tunnels, or other such facilities or attachments, and any encasements containing such facilities, including those that convey electricity, gases, steam, liquid petroleum produits, liaphone or other communications, cable television, water, wastewater, sto me ater, other liquids or chemicals, or traffic or other control systems.
- 49. Unit Price Work Wak to be a forton the basis of unit prices.
- 50. Work The grant construction or the various separately identifiable parts thereof required to be provided under the Contract Documents. Work includes and is the result of per trming or roviding all labor, services, and documentation necessary to produce such anstruction, and furnishing, installing, and incorporating all materials and equipment in each construction, all as required by the Contract Documents.
- 51. Work Change Directive A written statement to Contractor issued on or after the Effective Date of the Agreement and signed by Owner and recommended by Engineer ordering an addition, deletion, or revision in the Work, or responding to differing or unforeseen subsurface or physical conditions under which the Work is to be performed or to emergencies. A Work Change Directive will not change the Contract Price or the Contract Times but is evidence that the parties expect that the change ordered or documented by a Work Change Directive will be incorporated in a subsequently issued Change Order following negotiations by the parties as to its effect, if any, on the Contract Price or Contract Times.

1.02 Terminology

A. The following words or terms are not defined but, when used in the Bidding Requirements or Contract Documents, have the following meaning.

B. Intent of Certain Terms or Adjectives

1. The Contract Documents include the terms "as allowed," "as approved," "as ordered," "as directed" or terms of like effect or import to authorize an exercise of professional judgment by Engineer. In addition, the adjectives "reasonable," "suitable," "acceptable," "proper," "satisfactory," or adjectives of like effect or import are used to describe an action or determination of Engineer as to the Work. It is intended that such exercise of professional judgment, action or determination will be solely to evaluate, in general, the Work for compliance with the requirements of and information in the Contract Documents and conformance with the design concept of the completed Project as a functioning whole as down or indicated in the Contract Documents (unless there is a specific statem at adicating otherwise). The use of any such term or adjective is not intended to and sold not be effective to assign to Engineer any duty or authority to supervise or direct the performance of the Work or any duty or authority to undertake asponsibility contrary to the provisions of Paragraph 9.07 or any other provision of the contract Documents.

C. Day

1. The word "day" means a calenda da of the hours measured from midnight to the next midnight.

D. Defective

- 1. The word "de tot." Wen modifying the word "Work," refers to Work that is unsatisfactor, faulty, identification.
 - a. does not inform to the Contract Documents, or
 - b. does not me the requirements of any applicable inspection, reference standard, test, or approval referred to in the Contract Documents, or
 - c. has been damaged prior to Engineer's recommendation of final payment (unless responsibility for the protection thereof has been assumed by Owner at Substantial Completion in accordance with Paragraph 14.04 or 14.05).
 - d. Fails to perform to industry standards within the geographic area of the Project at any time during the Correction Period specified in Paragraph 13.07.
- E. Furnish, Install, Perform, Provide

- The word "furnish," when used in connection with services, materials, or equipment, shall mean to supply and deliver said services, materials, or equipment to the Site (or some other specified location) ready for use or installation and in usable or operable condition.
- 2. The word "install," when used in connection with services, materials, or equipment, shall mean to put into use or place in final position said services, materials, or equipment complete and ready for intended use.
- 3. The words "perform" or "provide," when used in connection with services, materials, or equipment, shall mean to furnish and install said services, materials, or equipment complete and ready for intended use.
- 4. When "furnish," "install," "perform," or "provide" is not used in connection with services, materials, or equipment in a context clearly requiring an obligation of Contractor, "provide" is implied.
- F. Unless stated otherwise in the Contract Documents, work or phrases which have a well-known technical or construction industry or tade meaning are used in the Contract Documents in accordance with such recognized meaning.

ARTICLE 2 - PRELIMINARY MATTERS

- 2.01 Delivery of Bonds and Evidence of Instrant.
 - A. Bonds: When Contractor delight the excuted counterparts of the Agreement to Owner, Contractor shall also delight to when such bonds as Contractor may be required to furnish pursuant to Paragraph 7. Whof the Agreement.
 - B. Evidence of Insurance Reformany Work at the Site is started, Contractor shall deliver to Owner, certificates of insurance and other evidence of insurance which Owner or any additional insure Lmay reas mably request) which Contractor is required to purchase and maintain in accordance with Article 5.

2.02 Copies of Documents

- A. Owner shall furnish to Contractor the number of printed or hard copies of the Contract Documents specified in Paragraph 9.06.C of the Agreement. Additional copies will be furnished upon request at the cost of reproduction.
- 2.03 Commencement of Contract Times; Notice to Proceed
 - A. The Contract Times will commence to run on the thirtieth day after the Effective Date of the Agreement or, if a Notice to Proceed is given, on the day indicated in the Notice to Proceed. A Notice to Proceed may be given at any time within 30 days after the Effective

Date of the Agreement. In no event will Owner have any obligations or duties to Contractor under the Agreement until Contract Times commence to run.

2.04 Starting the Work

A. Contractor shall start to perform the Work on the date when the Contract Times commence to run. No Work shall be done at the Site prior to the date on which the Contract Times commence to run.

2.05 Preliminary Schedules

- A. Submission of Preliminary Schedules: Within 10 days after the Effective Date of the Agreement (unless otherwise specified by Owner or Engineer in writing or at the Preconstruction Conference), Contractor shall submit to Engineer for timely review:
 - 1. a preliminary Progress Schedule indicating the times (numbers of days or dates) for starting and completing the various stages of Work, including any Milestones specified in the Contract Documents;
 - 2. a preliminary Schedule of Submittals; ap
 - 3. a preliminary Schedule of Values for all fine Work which includes quantities and prices of items which when added together qual the Contract Price and subdivides the Work into component parts it subject detail to serve as the basis for progress payments during performance of the John Such prices will include an appropriate amount of overhead and the applicable to each item of Work.
- B. Acceptance of Preliminal Schembles: No progress payment shall be made to Contractor until schedules are submit of Engineer in accordance with Paragraph 2.05.A and accepted by Engineer.
 - 1. The Progress Schedul will be acceptable to Engineer if it provides an orderly progression to the Work to completion within the Contract Times. Such acceptance will not impose the Engineer responsibility for the Progress Schedule, for sequencing, scheduling, or progress of the Work nor interfere with or relieve Contractor from Contractor's full responsibility therefor.
 - 2. Contractor's Schedule of Submittals will be acceptable to Engineer if it provides a workable arrangement for reviewing and processing the required submittals.
 - Contractor's Schedule of Values will be acceptable to Engineer as to form and substance if it provides a reasonable allocation of the Contract Price to component parts of the Work and the allocation of the Contract Price as shown in the Progress Schedule.

2.06 Preconstruction Conference; Designation of Authorized Representatives

- A. Before any Work at the Site is started, a conference attended by Owner, Contractor, Engineer, and others as appropriate will be held to establish a working understanding among the parties as to the Work and to discuss the schedules referred to in Paragraph 2.05.A, procedures for handling Shop Drawings and other submittals, processing Applications for Payment, and maintaining required records.
- B. At this conference Owner and Contractor shall each designate, in writing, specific individuals to act as their respective representatives with respect to the services and responsibilities of each party under the Contract. Such individuals shall have the authority to transmit instructions, receive information, render decisions relative to the Contract, and otherwise act on behalf of each respective party.

ARTICLE 3 - CONTRACT DOCUMENTS: INTENT, AMENDING REUSE

3.01 Intent

- A. The Contract Documents are complementary: That is required by one is as binding as if required by all.
- B. It is the intent of the Contract Documents to cribe a functionally complete project (or part thereof) to be constructed in accordance with the Contract Documents. Any labor, documentation, services, materials, they ment hat may reasonably be inferred from the Contract Documents or from prevailing custom or trade usage as being required to produce the indicated results in the proceed whether or not specifically called for at no additional cost to Owner.
- C. Clarifications and interprets as of the Contract Documents shall be issued by Engineer as provided in Articles

3.02 Reference Stand ds

- A. Standards, Specific tions, odes, Laws, and Regulations
 - Reference to standards, specifications, manuals, or codes of any technical society, organization, or association, or to Laws or Regulations, whether such reference be specific or by implication, shall mean the standard, specification, manual, code, or Laws or Regulations in effect at the time of opening of Bids (or on the Effective Date of the Agreement if there were no Bids), except as may be otherwise specifically stated in the Contract Documents.
 - 2. No provision of any such standard, specification, manual or code, or any instruction of a Supplier shall be effective to change the duties or responsibilities of Owner, Contractor, or Engineer, or any of their subcontractors, consultants, agents, or

employees from those set forth in the Contract Documents. No such provision or instruction shall be effective to assign to Owner, or Engineer, or any of their Related Entities, any duty or authority to supervise or direct the performance of the Work or any duty or authority to undertake responsibility inconsistent with the provisions of the Contract Documents.

B. Unless specified otherwise in the Contract Documents, all Work shall meet the laws, regulations, codes, and industry standards (in that order) applicable to the location of the Work.

3.03 Reporting and Resolving Discrepancies

A. Reporting Discrepancies

- 1. Contractor's Review of Contract Documents Before Starting Work: Before undertaking each part of the Work, Contractor shall carefully study and compare the Contract Documents and check and verify pertinal figures therein and all applicable field measurements. Contractor shall prompay report in writing to Engineer any conflict, error, ambiguity, or discrepancy which Contractor discovers or has actual knowledge of and shall obtain a writter interpretation of clarification from Engineer before proceeding with any Work affects of the aby.
- 2. Contractor's Review of Contract occuments Suring Performance of Work: If, during the performance of the Work, Contract of discovers any conflict, error, ambiguity, or discrepancy within the Contract Documents of between the Contract Documents and any provision of any Law of pegula on applicable to the performance of the Work or of any standard, specification manual or code, or of any instruction of any Supplier, Contractor shall prohebly received Engineer in writing. Contractor shall not proceed with the Work affected vereby (except in an emergency as required by Paragraph 6.15.A) until a mount ation to the Contract Documents has been issued by one of the methods in scated in Fragraph 3.04.
- 3. Contractor sha not bruiable to Owner or Engineer for failure to report any conflict, error, ambiguity, ascrepancy in the Contract Documents unless Contractor had actual knowledge thereof.

B. Resolving Discrepancies

Except as may be otherwise specifically stated in the Contract Documents, the
provisions of the Contract Documents shall take precedence in resolving any conflict,
error, ambiguity, or discrepancy between the provisions of the Contract Documents
and:

- a. the provisions of any standard, specification, manual, code, or instruction (whether or not specifically incorporated by reference in the Contract Documents); or
- b. the provisions of any Laws or Regulations applicable to the performance of the Work (unless such an interpretation of the provisions of the Contract Documents would result in violation of such Law or Regulation).

3.04 Modifying Contract Documents

- A. The Contract Documents may be modified to provide for additions, deletions, or revisions (or any combination thereof) in the Work or to modify the terms and conditions thereof by either a Change Order or a Work Change Directive.
- B. The requirements of the Contract Documents may be supplemented, and minor variations and deviations in the Work may be authorized, by one more of the following ways:
 - 1. Work Change Directive
 - 2. Change Order
 - 3. Field Order;
 - 4. Engineer's approval of a Shop D. sing of Sample (subject to the provisions of Paragraph 6.16.D.3); or
 - 5. Engineer's written intermetation or derification.
- C. Changes in Contract Time of Contract

3.05 Reuse of Documen

- A. Contractor and a Subconfactor or Supplier shall not:
 - 1. have or acquire a saile to or ownership rights in any of the Drawings, Specifications, or other documents (or copies of any thereof) prepared by or bearing the seal of Engineer or its consultants, including electronic media editions; or
 - 2. reuse any of such Drawings, Specifications, other documents, or copies thereof on extensions of the Project or any other project without written consent of Owner and Engineer and specific written verification or adaptation by Engineer.
- B. The prohibition of this Paragraph 3.05 will survive final payment, or termination of the Contract. Nothing herein shall preclude Contractor from retaining copies of the Contract Documents for record purposes.

3.06 Electronic Data

- A. Copies of data furnished by Owner or Engineer to Contractor or Contractor to Owner or Engineer that may be relied upon are limited to the printed copies (also known as hard copies). Files in electronic media format of text, data, graphics, or other types are furnished only for the convenience of the receiving party. Any conclusion or information obtained or derived from such electronic files will be at the user's sole risk. If there is a discrepancy between the electronic files and the hard copies, the hard copies govern.
- B. Because data stored in electronic media format can deteriorate or be modified inadvertently or otherwise without authorization of the data's creator, the party receiving electronic files agrees that it will perform acceptance tests or procedures within 60 days, after which the receiving party shall be deemed to have accepted the data thus transferred. Any errors detected within the 60-day acceptance period will be corrected by the transferring party.
- C. When transferring documents in electronic media for not the transferring party makes no representations as to long term compatibility basishing or readability of documents resulting from the use of software application tackages, operating systems, or computer hardware differing from those used by the data's creator.

ARTICLE 4 – AVAILABILITY OF LANDS; SUBSURPAGE AND PHYSICAL CONDITIONS; HAZARDOUS ENVIRONMENTAL CONDITIONS: REFERENCE POINTS

4.01 Availability of Lands

- A. Owner shall furnish the Site. Other shall notify Contractor of any encumbrances or restrictions not of general applies to but specifically related to use of the Site with which Contractor must comply in proorning the Work. Owner will obtain in a timely manner and pay for easements of primark at structures or permanent changes in existing facilities. If Contractor and I when are mable to agree on entitlement to or on the amount or extent, if any, of any adjustment in the Contract Price or Contract Times, or both, as a result of any delay in Owner's as nishing the Site or a part thereof, Contractor may make a Claim therefor as provided in Pragraph 10.05.
- B. Upon reasonable written request, Owner shall furnish Contractor with a current statement of record legal title and legal description of the lands upon which the Work is to be performed and Owner's interest therein as necessary for giving notice of or filing a mechanic's or construction lien against such lands in accordance with applicable Laws and Regulations.
- C. Contractor shall provide for all additional lands and access thereto that may be required for temporary construction facilities or storage of materials and equipment.

4.02 Subsurface and Physical Conditions

A. Reports and Drawings:

- 1. A Geotechnical Report, if any, is included as a Contract Document and is attached hereto as Exhibit G.
- Reports of explorations and tests of subsurface conditions at the Site known to Owner and drawings of physical conditions relating to existing surface and subsurface structures (except Underground Facilities) at the Site known to Owner, if any, are attached hereto as Exhibit H.
- 3. Copies of reports and drawings itemized in Exhibit I that are not included with Bidding Documents may be examined at the address listed in paragraph 9.06.D of the Agreement. Such examination is allowed during regular business hours. These reports and drawings are not part of the contract Documents. Contractor is not entitled to rely upon any information or data in any report or drawing itemized in Exhibit I except as set forth in paragraph 4.02.
- 4. No other reports of explorations or tests of subsurface conditions at or contiguous to the Site were use in the preparation of the Drawings and Specifications, unless otherwise specific at in writing.
- B. Limited Reliance by Contractor At hone of The Geotechnical Report, which is a Contract Document, presents as a contract and seline those subsurface conditions that Contractor may assure it will a pounte however, Owner does not warrant that actual conditions will not vary from the assured conditions. Contractor may rely upon the express statements and expictive searcing assumed subsurface conditions at the Site presented as a contractual faseline in the Geotechnical Baseline Report, which is a Contract Document and expirit such reliance, Contractor may not rely upon or make any claim against Order or Engineer, or any of their Related Entities, with respect to:
 - 1. the completeness of the Geotechnical Report, or content, quality, or completeness of any other such to as, tests, or drawings for Contractor's purposes, including, but not limited to, any aspects of the means, methods, techniques, sequences, and procedures of construction to be employed by Contractor, and safety precautions and programs incident thereto; or
 - 2. other data, interpretations, opinions, and information contained in any such reports or tests, or shown or indicated in any such drawings; or
 - any Contractor interpretation of or conclusion drawn from any such report, test, or drawing or any such other data, interpretations, opinions, or information.

4.03 Differing Subsurface or Physical Conditions

A. Notice

- The Contractor shall give written notice to Owner and Engineer of (a) subsurface or latent physical conditions at the Site which differ materially from those indicated in the Geotechnical Baseline Report or other Contract Documents or (b) unknown physical conditions at the Site of an unusual nature that differ materially from those ordinarily encountered and generally recognized as inhering in work of the character provided for in the Contract Documents.
- 2. The Contractor's notice shall provide the Owner and Engineer the opportunity to investigate the conditions at the Site, and to obtain additional exploration or tests with respect to the pertinent condition. Owner shall provide to Contractor the results of any such additional tests or exploration.
- B. *Engineer's Review*: After receipt of written notice to required by Paragraph 4.03.A, Engineer will promptly review the pertinent condition, determine the necessity of Owner's obtaining additional exploration or tests with respect therete and advise Owner in writing (with a copy to Contractor) of Engineer's finely gs and conclusions.
- C. Possible Price and Times Adjustments
 - 1. The Contract Price or the Contract has or both, will be equitably adjusted to the extent that the existence of such a fering satisface or physical condition causes an increase or decrease in Contractor cost of, or time required for, performance of the Work; subject, however, to the following:
 - a. such condition meet at least one of the two categories described in Paragraph ... 1; d
 - b. with respect to Work that is paid for on a Unit Price Basis, any adjustment in Contract Lice will be subject to the provisions of Paragraphs 9.05 and 11.03.
 - 2. Contractor shall not be entitled to any adjustment in the Contract Price or Contract Times if:
 - a. Contractor knew of the existence of such conditions at the time Contractor made a final commitment to Owner with respect to Contract Price and Contract Times by the submission of a Bid or becoming bound under a negotiated contract; or
 - the existence of such condition could reasonably have been discovered or revealed as a result of any examination, investigation, exploration, test, or study of the Site and contiguous areas required by the Bidding Requirements or

Contract Documents to be conducted by or for Contractor prior to Contractor's making such final commitment; or

- c. Contractor failed to give the written notice as required by Paragraph 4.03.A.
- 3. If Owner and Contractor are unable to agree on entitlement to or on the amount or extent, if any, of any adjustment in the Contract Price or Contract Times, or both, Contractor may make a Claim therefor as provided in Paragraph 10.05. However, Owner and Engineer, and any of their Related Entities shall not be liable to Contractor for any claims, costs, losses, or damages (including but not limited to all fees and charges of engineers, architects, attorneys, and other professionals and all court or arbitration or other dispute resolution costs) sustained by Contractor on or in connection with any other project or anticipated project.

4.04 Underground Facilities

- A. Shown or Indicated: The information and data from or indicated in the Contract Documents with respect to existing Underground Facilities at or contiguous to the Site is based on information and data furnished to Conner or Engager by the owners of such Underground Facilities, including Owner, or by others. Unless it is otherwise expressly provided in the Contract Documents:
 - 1. Contractor may assume the coral accuracy and completeness of any such information and data shown or in calculate the contract Documents; and
 - 2. the cost of all of the following will be included in the Contract Price, and Contractor shall have full responsibility for:
 - a. reviewing and cheering all such information and data,
 - b. locating for field construction purposes all Underground Facilities shown or indicate Lin the Couract Documents,
 - c. coordination of the Work with the owners of such Underground Facilities, including Owner, during construction, and
 - d. the safety and protection of all such Underground Facilities and repairing any damage thereto resulting from the Work.

B. Not Shown or Indicated

If an Underground Facility is uncovered or revealed at or contiguous to the Site which
was not shown or indicated, or not shown or indicated with reasonable accuracy in
the Contract Documents, Contractor shall, promptly after becoming aware thereof
and before further disturbing conditions affected thereby or performing any Work in

connection therewith (except in an emergency as required by Paragraph 6.15.A), identify the owner of such Underground Facility and give written notice to that owner and to Owner and Engineer. Engineer will promptly review the Underground Facility and advise Owner as to the extent, if any, to which a change is required in the Contract Documents to reflect and document the consequences of the existence or location of the Underground Facility. During such time, Contractor shall be responsible for the safety and protection of such Underground Facility.

2. If Owner concludes that a change in the Contract Documents is required, a Work Change Directive or a Change Order will be issued to reflect and document such consequences. An equitable adjustment shall be made in the Contract Price or Contract Times, or both, to the extent that they are attributable to the existence or location of any Underground Facility that was not shown or indicated or not shown or indicated with reasonable accuracy in the Contract Documents and that Contractor did not know of and could not reasonably have been expected to be aware of or to have anticipated. If Owner and Contractor are unable to agree on entitlement to or on the amount or extent, if any, of any such adjust, and in Contract Price or Contract Times, Contractor may make a Claim therefor as provided in Paragraph 10.05.

4.05 Reference Points

A. Owner shall provide engineering surveys to stablish reference points and property monuments necessary to enable Cours for to proceed with the Work. Contractor shall be responsible for laying out the Work, and protect and preserve the established reference points and property monuments, and shall make no changes or relocations without the prior written approval of Owner. Contractor shall report to Engineer whenever any reference point or property honour and is lost or destroyed or requires relocation because of necessary changes in graces or locations, and shall be responsible for the accurate replacement or religious of such reference points or property monuments by professionally quartied pasons.

4.06 Hazardous Environmental Condition at Site

- A. Contractor shall not be responsible for any Hazardous Environmental Condition uncovered or revealed at the Site which was not shown or indicated in Drawings or Specifications or identified in the Contract Documents to be within the scope of the Work. Contractor shall be responsible for a Hazardous Environmental Condition created with any materials brought to the Site by Contractor, Subcontractors, Suppliers, or anyone else for whom Contractor is responsible.
- B. If Contractor encounters a Hazardous Environmental Condition or if Contractor or anyone for whom Contractor is responsible creates a Hazardous Environmental Condition, Contractor shall immediately: (i) secure or otherwise isolate such condition; (ii) stop all Work in connection with such condition and in any area affected thereby (except in an

emergency as required by Paragraph 6.15.A); and (iii) notify Owner and Engineer (and promptly thereafter confirm such notice in writing). Owner shall promptly consult with Engineer concerning the necessity for Owner to retain a qualified expert to evaluate such condition or take corrective action, if any. Promptly after consulting with Engineer, Owner shall take such actions as are necessary to permit Owner to timely obtain required permits and provide Contractor the written notice required by paragraph 4.06.C.

- C. Contractor shall not be required to resume Work in connection with such condition or in any affected area until after Owner has obtained any required permits related thereto and delivered written notice to Contractor: (i) specifying that such condition and any affected area is or has been rendered safe for the resumption of Work; or (ii) specifying any special conditions under which such Work may be resumed safely. If Owner and Contractor cannot agree as to entitlement to or on the amount or extent, if any, of any adjustment in Contract Price or Contract Times, or both, as a result of such Work stoppage or such special conditions under which Work is agreed to be resumed by Contractor, either party may make a Claim therefor as grovided in Paragraph 10.05.
- D. If after receipt of such written notice Contractor does he agree to resume such Work based on a reasonable belief it is unsafe, or cless not agree to resume such Work under such special conditions, then Owner may other the portion of the Work that is in the area affected by such condition to be deleted from the Work. If Owner and Contractor cannot agree as to entitlement to or on the amount or stent, if any, of an adjustment in Contract Price or Contract Times as a result deleted portion of the Work, then either party may make a Claim therefor as provided to stragraph 10.05. Owner may have such deleted portion of the Work performed by Owner's own forces or others in accordance with Article 7.
- E. To the fullest extent permitted by Law and Regulations, Owner shall indemnify and hold harmless Contractor Subcot factors, and Engineer, and the officers, directors, partners, employees, agence, consultant, and subcontractors of each and any of them from and against all claims, costs, lo ses, and damages (including but not limited to all fees and charges of engineers, architects, attorneys, and other professionals and all court or arbitration or other dispute resolution costs) arising out of or relating to a Hazardous Environmental Condition, provided that such Hazardous Environmental Condition: (i) was not shown or indicated in the Drawings or Specifications or identified in the Contract Documents to be included within the scope of the Work, and (ii) was not created by Contractor or by anyone for whom Contractor is responsible. Nothing in this Paragraph 4.06.E shall obligate Owner to indemnify any individual or entity from and against the consequences of that individual's or entity's own negligence.
- F. To the fullest extent permitted by Laws and Regulations, Contractor shall indemnify and hold harmless Owner and Engineer, and the officers, directors, partners, employees, agents, consultants, and subcontractors of each and any of them from and against all claims, costs, losses, and damages (including but not limited to all fees and charges of

engineers, architects, attorneys, and other professionals and all court or arbitration or other dispute resolution costs) arising out of or relating to a Hazardous Environmental Condition created by Contractor or by anyone for whom Contractor is responsible. Nothing in this Paragraph 4.06.F shall obligate Contractor to indemnify any individual or entity from and against the consequences of that individual's or entity's own negligence.

G. The provisions of Paragraphs 4.02, 4.03, and 4.04 do not apply to a Hazardous Environmental Condition uncovered or revealed at the Site.

4.07 Notice of Hazardous Materials

A. In accordance with the intent of the Federal Occupational Safety and Health Administration (OSHA) Standard Section 29 CFR 1910.1200, Hazard Communication with effective date of May 25, 1986, as it may be amended from time to time, the Owner hereby notifies the Contractor that Work is to be performed on company property where the Contractor's employees may be exposed to havardous materials existing on the premises.

Chemicals known to be used or stored by the Owner and required to be disclosed by said OSHA Standard Section 29 CFR 1910, 200 are listed in Exhibit J.

each provide or make available to the B. Owner, Contractor, and any Subcontractors others: (a) any written hazard comparization pagram required to be maintained with afer, tota sheet and other hazard communication respect to the site and any material information required to be provided in accordance with the applicable Laws and he event that applicable Laws and Regulations do not applicable Regulations; or (b) require the provision or a change of such hazard communications, Contractor and any Subcontractors shall, new the wide or make available to Owner and any other employers at the site a warn hazard communication program, material safety data sheets and other azars some unication information of the type and consistent with the intent of said Q AA Stand of Section 29 CFR 1910.1200 and acceptable to Owner and Engineer. Contractor shall be responsible for coordinating any such required exchange of documents or in smatter between or among Owner and any other employers at the Intractor shall include the provisions of this paragraph in any Site, or any of them. subcontract for any part of the Work at the site.

ARTICLE 5 - BONDS AND INSURANCE

- 5.01 Performance, Payment, and Other Bonds
 - A. If required by the Contract Documents, Contractor shall furnish performance and payment bonds, each in an amount at least equal to the Contract Price as security for the faithful performance and payment of all of Contractor's obligations under the Contract Documents. These bonds shall remain in effect until one year after the

- date when final payment becomes due or until completion of the correction period specified in Paragraph 13.07, whichever is later, except as provided otherwise by Laws or Regulations or by the Contract Documents. Contractor shall also furnish such other bonds as are required by the Contract Documents.
- B. All bonds shall be in the form prescribed by the Contract Documents except as provided otherwise by Laws or Regulations, and shall be executed by such sureties as are named in the list of "Companies Holding Certificates of Authority as Acceptable Sureties on Federal Bonds and as Acceptable Reinsuring Companies" as published in Circular 570 (amended) by the Financial Management Service, Surety Bond Branch, U.S. Department of the Treasury. All bonds signed by an agent or attorney-in-fact must be accompanied by a certified copy of that individual's authority to bind the surety. The evidence of authority shall show that it is effective on the date the agent or attorney-in-fact signed each bond.
- C. If the surety on any bond furnished by Contractor is declared bankrupt or becomes insolvent or its right to do business is termination any state where any part of the Project is located or it ceases to meet the requirements of Paragraph 5.01.B, Contractor shall promptly notify Owner and Engineer and shall, within 20 days after the event giving rise to such notification, provide another bond and surety, both of which shall comply with the requirement of aragraphs 5.01.B and 5.02.
- D. All bonds furnished in compliant, with the above shall be executed by sureties having a rating of "A" by the most receive the test's Key Rating Guide and as are named in the current list of "Companies Hading Certificates of Authority as Acceptable Sureties on Federal Bonds and as acceptable Reinsuring Companies" as published in Circular 570 (apranded) by the Audit Staff, Bureau of Government Financial Operations, U.S. The sure Department. All Bonds signed by an agent must be accompanied by a certical dopy of such agent's authority to act.

5.02 Licensed Sure s and Insuers

A. All bonds and hourant required by the Contract Documents to be purchased and maintained by Outant or Contractor shall be obtained from surety or insurance companies that are duly licensed or authorized in the jurisdiction in which the Project is located to issue bonds or insurance policies for the limits and coverages so required. Such surety and insurance companies shall also meet such additional requirements and qualifications as may be provided in these General Conditions.

5.03 Certificates of Insurance

A. Contractor shall deliver to Owner, with copies to each additional insured identified in Exhibit K, certificates of insurance (and other evidence of insurance requested by

Owner or any other additional insured) which Contractor is required to purchase and maintain.

- B. Failure of Owner to demand such certificates or other evidence of full compliance with these insurance requirements or failure of Owner to identify a deficiency from evidence provided shall not be construed as a waiver of Contractor's obligation to maintain such insurance.
- C. Owner does not represent that coverage and limits will necessarily be adequate to protect Contractor against all risks, including Contractor's obligation to indemnify Owner.
- D. The insurance and insurance limits required herein shall not be deemed as a limitation on Contractor's liability under the indemnities granted to Owner in the Contract Documents.

5.04 Contractor's Insurance

- A. Contractor shall purchase and maintain such insurance as is appropriate for the Work being performed and as will provide protection from claims set forth below which may arise out of or result from Contractor's performance of the Work and Contractor's other obligations under the Contract Documents, whether it is to be performed by Contractor, any Subcontractor is Supplied or by anyone directly or indirectly employed by any of them to perform all of the Work, or by anyone for whose acts any of them may be liable:
 - 1. claims under workers' compensation, disability benefits, and other similar employee benefits:
 - 2. claims for tank ses in cause of bodily injury, occupational sickness or disease, or death of Contra tor's imployees;
 - 3. claims for samage because of bodily injury, sickness or disease, or death of any person the man Contractor's employees;
 - 4. claims for damages insured by reasonably available personal injury liability coverage which are sustained:
 - a. by any person as a result of an offense directly or indirectly related to the employment of such person by Contractor, or
 - b. by any other person for any other reason;

- claims for damages, other than to the Work itself, because of injury to or destruction of tangible property wherever located, including loss of use resulting therefrom; and
- 6. claims for damages because of bodily injury or death of any person or property damage arising out of the ownership, maintenance or use of any motor vehicle.
- B. The policies of insurance required by this Paragraph 5.04 shall:
 - with respect to insurance required by Paragraphs 5.04.A.3 through 5.04.A.6 inclusive, be written on an occurrence basis, include as additional insureds (subject to any customary exclusion regarding professional liability) Owner and Engineer, and any other individuals or entities identified in Exhibit K, all of whom shall be listed as additional insureds, and include coverage for the respective officers, directors, partners, employees, agents consultants and subcontractors of each and any of all such additional insureds, and the insurance afforded to these additional insureds shall provide primal coverage for all claims covered thereby;
 - 2. include at least the specific coverar is provided in Exhibit L or required by Laws or Regulations, whichever is greaten
 - 3. include contractual liability is trance coording Contractor's indemnity obligations under Paragraphs 6.11 and 119,
 - 4. contain a provision endon ment that the coverage afforded will not be ged & y cha renewal refused until at least 30 days prior canceled, materia written notice be Owner and Contractor and to each other tified in Exhibit K to whom a certificate of insurance has additional insured been issu certificates of insurance furnished by the Contractor ph 3 33 will so provide); pursua to Parag
 - 5. remain in ffect a least until final payment and at all times thereafter when Contractor be correcting, removing, or replacing defective Work in accordance with Paragraph 13.07; and
 - 6. include completed operations coverage:
 - a. Such insurance shall remain in effect for three years after final payment.
 - b. Contractor shall furnish Owner and each other additional insured identified in Exhibit K, to whom a certificate of insurance has been issued, evidence satisfactory to Owner and any such additional insured of continuation of such insurance at final payment and one year thereafter.

- C. The limits of liability for the insurance required by Paragraph 5.04 of the General Conditions shall provide coverage for not less than the following amounts or greater where required by Laws and Regulations.
 - 1. At no expense to Owner, Contractor shall (1) obtain and keep in force during the term of this Agreement, and any renewals or extensions hereof; and (2) require its subcontractors to obtain and keep in force during the terms of their respective engagements or contracts, the minimum insurance limits and coverage set forth in Exhibit L. The insurance coverage limits stated therein are minimum coverage requirements, not limitations of liability, and shall not be construed in any way as Owner's acceptance of the responsibility of Contractor.
 - 2. The minimum liability limits required may be satisfied through the combination of the primary general liability, employers' liability, and automotive liability limits with an umbrella liability policy (with coverage no more restrictive than the underlying insurance) providing excess limits (least equal to or greater than the combined primary limits.
 - 3. All commercial general liability including completes operations-products liability coverage and automotive liability issurance shall designate Owner, its parent, affiliates and subsidiaries, their respective directors, officers and employees as additional insureds. All such insurance should be primary and non-contributory, and is required to respond a proprior to any other insurance or self-insurance available to Owner. In addition to the shillity limits available, such insurance will pay on behalf of or will indem if Owner for defense costs. Any other coverage available to Owner applies on contingent and excess basis. Such insurance shall include appropriate clause pursuant to which the insurance companies shall wave its right of subrogation against Owner.
 - 4. Contractor and any of subcontractors shall furnish, prior to the start of work, certificates or adecrate proof of the foregoing insurance including, if specifically requested by Owner, copies of the endorsements and insurance policies naming Owner as a paditional insured, as provided herein. Current certificates of insurance shall be provided prior to the commencement of work and shall be maintained until termination of this Agreement. Contractor shall notify Owner in writing, at least thirty (30) calendar days prior to cancellation, or of a material change in any policy.
 - 5. The certificate holder is included as an additional insured with respect to liability arising out of the named insured's operations performed on behalf of such certificate holder. A waiver of any subrogation endorsement must accompany a certificate of insurance and must include workers' compensation policies.

- 6. Carriers providing coverage will be rated by A.M. Best with at least an A-rating and a financial size category of at least Class VII. Such cancellation or material alteration shall not relieve Contractor of its continuing obligation to maintain insurance coverage in accordance with this contract. Carriers shall be licensed in the state(s) where work is performed.
- 7. If Contractor shall fail to procure and maintain such insurance, Owner, upon written notice, may, but shall not be required to, procure and maintain same, but at the expense of Contractor. In the alternative, Owner may declare a default hereunder and, unless such default is timely cured, terminate the Agreement. Unless and until the default is cured, neither Contractor nor its servants, employees or agents will be allowed to enter upon the Owner's premises.

5.05 Owner's Liability Insurance

A. In addition to the insurance required to be provided by Contractor under Paragraph 5.04, Owner, at Owner's option, may purchase and maintain at Owner's expense Owner's own liability insurance as will protect Owner's paint claims which may arise from operations under the Contract Documents.

5.06 Property Insurance – Builder's Risk Insurance

The Contractor shall bear all risks of charges or danage to the materials and Work until the Work is finally accepted by the Owner excepted the Contractor may claim reimbursement policy as herein provided and limited. Owner under the Owner's builder's risk insur may carry "All Risk" Builders Als. Insura ce subject to deductibles, terms and conditions as stated in the policy and is the obligation and responsibility of the Contractor to JOW. make appropriate claim company for all losses claimed under the policy. d under this policy, in whole in or parts, the Contractor shall Should any loss not be cov bear the loss. A que "ions egarding coverages, limitation, exclusion, etc. contained in the policy shall be address Management, a perican V sed bidders prior to submittal of bids, to Director, Risk ter, 1025 Laurel Oak Road, Voorhees, NJ 08043.

Such insurance shall so fer the full value of the cost of replacement to the Owner, less applicable deductibles, of all completed portions of the work to be performed throughout the entire time of construction. The deductibles on each separate and unrelated loss are: (1) \$25,000 on loss; (2) \$250,000 on loss caused by flood; (3) 5% of total insurable value for loss caused by earthquake. Owner will furnish to the Contractor evidence of the insurance coverage provided.

Such insurance shall not cover (1) damage to or loss of material or equipment furnished by either party which are damaged or lost due to carelessness or negligence on the part of the Contractor, or (2) damage to or loss of machinery, tools, equipment, or other property furnished by the Contractor whether or not used by the Contractor in carrying out the terms of the Contract unless such machinery, tools, equipment or other property are specifically

intended for permanent incorporation into the Contract work and are included in an approved application for payment.

5.07 Waiver of Rights

A. Owner and Contractor intend that all policies purchased in accordance with Paragraph 5.06 will protect Owner, Contractor, Subcontractors, and Engineer, and all other individuals or entities identified in Exhibit K to be listed as loss payees (and the officers, directors, partners, employees, agents, consultants and subcontractors of each and any of them) in such policies and will provide primary coverage for all losses and damages caused by the perils or causes of loss covered thereby. All such policies shall contain provisions to the effect that in the event of payment of any loss or damage the insurers will have no rights of recovery against any of the insureds or loss payees thereunder. Owner and Contractor waive all rights against each other and their respective officers, directors, partners, employees, agents, consultants and subcontractors of each and any of them for all osses and damages caused by, arising out of or resulting from any of the peril of causes of loss covered by such policies and any other property insurance applicable to the Work; and, in addition, waive all such rights against Subcontracters, and Engileer, and all other individuals or entities identified in Exhibit K to be list d as los payees (and the officers, directors, and subcontractors of each and any of partners, employees, agents, consultant them) under such policies for losses and smages so caused. None of the above waivers shall extend to the rights and making such waiver may have to the proceeds of insurance held by Cyner trustee or otherwise payable under any policy so issued.

5.08 Receipt and Application of Insurance Proceeds

- A. Any insured loss under the policies of insurance required by Paragraph 5.06 will be adjusted with awner and in de payable to Owner as fiduciary for the loss payees, as their interests may appear, subject to the requirements of any applicable mortgage clause and to Paragraph 5.08.B. Owner shall deposit in a separate account any money so received any shall distribute it in accordance with such agreement as the parties in interest to reach. If no other special agreement is reached, the damaged Work shall be repaired or replaced, the moneys so received applied on account thereof, and the Work and the cost thereof covered by an appropriate Change Order.
- B. Owner as fiduciary shall have power to adjust and settle any loss with the insurers unless one of the parties in interest shall object in writing within 15 days after the occurrence of loss to Owner's exercise of this power. If such objection be made, Owner as fiduciary shall make settlement with the insurers in accordance with such agreement as the parties in interest may reach. If no such agreement among the parties in interest is reached, Owner as fiduciary shall adjust and settle the loss with

the insurers and, if required in writing by any party in interest, Owner as fiduciary shall give bond for the proper performance of such duties.

5.09 Acceptance of Bonds and Insurance; Option to Replace

A. If either Owner or Contractor has any objection to the coverage afforded by, or other provisions of, the bonds or insurance purchased and maintained by the other party in accordance with Article 5 on the basis of non-conformance with the Contract Documents, the objecting party shall so notify the other party in writing within 10 days after receipt of the certificates or other requested evidence of coverage. Owner and Contractor shall each provide to the other such additional information in respect of insurance provided as the other may reasonably request. If either party does not purchase or maintain all of the bonds and insurance required of such party by the Contract Documents, such party shall notify the other party in writing of such failure to purchase prior to the start of the Work, or of such ailure to maintain prior to any change in the required coverage. Without prejudic to any other right or remedy, the other party may elect to obtain equivalent bon a insurance to protect such other party's interests at the expense of the party who as required to provide such coverage, and a Change Order shall e issued to adjust the Contract Price accordingly.

5.10 Partial Utilization, Acknowledgment of Property Source

A. If Owner finds it necessary to occup or the approvision or portions of the Work prior to Substantial Completion of all the Work as provided in Paragraph 14.05, no such use or occupancy shall commence to fore the insurers providing the property insurance pursuant to Paragraph 5 % have taken deed notice thereof and in writing effected any changes in coverage necessitation to by. The insurers providing the property insurance shall consent by endorsement on the policy or policies, but the property insurance shall not be canceled observed to appear on account of any such partial use or occupancy.

ARTICLE 6 - CONTRACTOR'S REPONSIBILITIES

6.01 Supervision and Supervision dence

A. Contractor shall supervise, inspect, and direct the Work competently and efficiently, devoting such attention thereto and applying such skills and expertise as may be necessary to perform the Work in accordance with the Contract Documents. Contractor shall be solely responsible for the means, methods, techniques, sequences, and procedures of construction. Contractor shall not be responsible for the negligence of Owner or Engineer in the design or specification of a specific means, method, technique, sequence, or procedure of construction which is shown or indicated in and expressly required by the Contract Documents.

- B. At all times during the progress of the Work, Contractor shall assign a competent resident superintendent, acceptable to Owner, who shall not be replaced without written authorization from Owner except under extraordinary circumstances.
- C. If required by Owner, the Contractor shall assign the project manager listed in Exhibit M who shall not be replaced without written notice to Owner and Engineer except under extraordinary circumstances.

6.02 Labor; Working Hours

- A. Contractor shall provide competent, suitably qualified personnel to survey and lay out the Work and perform construction as required by the Contract Documents. Contractor shall at all times maintain good discipline and order at the Site.
- B. Except as otherwise required for the safety or protection of persons or the Work or property at the Site or adjacent thereto, and except a otherwise stated in the Contract Documents, all Work at the Site shall be performed during regular working hours. Contractor will not permit the performance of Work on a Saturday, Sunday, or any legal holiday without Owner's written consent (which will not be preasonably withheld) given after prior written notice to Engineer.

6.03 Services, Materials, and Equipment

- A. Unless otherwise specified in the Contract Dockments, Contractor shall provide and assume full responsibility for all ser ces ma rials, equipment, labor, transportation, construction equipment and machine, tools, appliances, fuel, power, light, heat, telephone, water, sanitary facilities, temporary facilities, and all other facilities and incidentals necessary for the per france, testing, start-up, and completion of the Work.
- B. All materials and components corporated into the Work shall be as specified or, if not specified, shall be of good malk, and new, except as otherwise provided in the Contract Documents. All special war anties and guarantees required by the Specifications shall expressly run to be beneff of Owner. If required by Engineer, Contractor shall furnish satisfactory evidence (including reports of required tests) as to the source, kind, and quality of materials and equipment.
- C. All materials and equipment shall be stored, applied, installed, connected, erected, protected, used, cleaned, and conditioned in accordance with instructions of the applicable Supplier, except as otherwise may be provided in the Contract Documents.

6.04 Progress Schedule

A. Contractor shall adhere to the Progress Schedule established in accordance with Paragraph 2.05 as it may be adjusted from time to time as provided below.

- 1. Contractor shall submit to Engineer for acceptance (to the extent indicated in Paragraph 2.05) proposed adjustments in the Progress Schedule that will not result in changing the Contract Times. Such adjustments will comply with any provisions of the General Requirements applicable thereto.
- 2. Proposed adjustments in the Progress Schedule that will change the Contract Times shall be submitted in accordance with the requirements of Article 12. Adjustments in Contract Times may only be made by a Change Order.

6.05 Substitutes and "Or-Equals"

A. Whenever an item of material or equipment is specified or described in the Contract Documents by using the name of a proprietary item or the name of a particular Supplier, no like, equivalent, or "or-equal" item, and no substitution, is permitted.

6.06 Concerning Subcontractors, Suppliers, and Others

- A. Contractor shall not employ any Subcontractor, Supplier, or other individual or entity (including those acceptable to Owner as indicated in Paragraph 6.06.B), whether initially or as a replacement, against whom Owner hay have reasonable objection. Contractor shall not be required to employ any Subcontractor, Supplier, or other individual or entity to furnish or perform any of the Work against warm Contractor has reasonable objection.
- B. If the Contract Documents require to a lastity of certain Subcontractors, Suppliers, or other individuals or entities to be sumificant. Owner for Owner's acceptance by a ate of the Agreement, and if Contractor has specified date prior to the stive ` submitted a list thereof in corda ce with the Contract Documents, Owner's acceptance (either in writing or by facing to writen objection thereto by the date indicated for acceptance or objection in Bidding Documents or the Contract Documents) of any such Subcontracte Su, Vier, other individual or entity so identified may be revoked by Owner on the asis of a sont le objection after due investigation. Contractor shall submit an acceptable replacement for the rejected Subcontractor, Supplier, or other individual or entity, and the Contract Price will be adjusted by the difference in the cost occasioned by such look cement, and an appropriate Change Order will be issued. No acceptance by Owner of any such Subcontractor, Supplier, or other individual or entity, whether initially or as a replacement, shall constitute a waiver of any right of Owner or Engineer to reject defective Work.
- C. Contractor shall be fully responsible to Owner and Engineer for all acts and omissions of the Subcontractors, Suppliers, and other individuals or entities performing or furnishing any of the Work just as Contractor is responsible for Contractor's own acts and omissions. Nothing in the Contract Documents:

- 1. shall create for the benefit of any such Subcontractor, Supplier, or other individual or entity any contractual relationship between Owner or Engineer and any such Subcontractor, Supplier or other individual or entity, nor
- 2. shall create any obligation on the part of Owner or Engineer to pay or to see to the payment of any moneys due any such Subcontractor, Supplier, or other individual or entity except as may otherwise be required by Laws and Regulations.
- D. Contractor shall be solely responsible for scheduling and coordinating the Work of Subcontractors, Suppliers, and other individuals or entities performing or furnishing any of the Work under a direct or indirect contract with Contractor.
- E. Contractor shall require all Subcontractors, Suppliers, and such other individuals or entities performing or furnishing any of the Work to communicate with Engineer through Contractor.
- F. The divisions and sections of the Specifications applies identifications of any Drawings shall not control Contractor in dividing the Work among Subcontractors or Suppliers or delineating the Work to be performed by any specific trace. This paragraph does not authorize Contractor to assign work to Subcontractors of Suppliers in violation of licensing requirements or other laws and resolutions.
- G. All Work performed for Contractor by Subcontactor or Supplier will be pursuant to an appropriate written agreement between actor of Supplier to the Subcontractor or Supplier which specifically binds the Subcontactor of Supplier to the applicable terms and conditions of the Contract Dead ents in the benefit of Owner and Engineer. Whenever any such agreement is wan a Subcontractor or Supplier who is listed as an additional insured on the property acturate a middle in Paragraph 5.06, the agreement between the Contractor and the Subcontractor or Supplier will contain provisions whereby the Subcontractor or Supplier wants all rights against Owner, Contractor, Engineer, and all other individuals or entities dentated in the Contract Documents to be listed as insureds or additional intereds (art) the respective officers, directors, partners, employees, agents, consultants and subcontractors of each and any of them) for all losses and damages caused by, a sing out of, relating to, or resulting from any of the perils or causes of loss covered by such policies and any other property insurance applicable to the Work. If the insurers on any such policies require separate waiver forms to be signed by any Subcontractor or Supplier, Contractor will obtain the same.
- H. Owner or Engineer may furnish to any Subcontractor or Supplier, to the extent practicable, information about amounts paid to Contractor on account of Work performed for Contractor by a particular Subcontractor or Supplier.
- I. Subcontractors approved by the Owner and Engineer are listed in Exhibit N. Approved Subcontractors shall not be replaced without prior notice to Owner. Owner shall have all

rights provided in this Paragraph 6.06 with respect to any proposed replacement Subcontractor.

6.07 Patent Fees and Royalties

- A. Contractor shall pay all license fees and royalties and assume all costs incident to the use in the performance of the Work or the incorporation in the Work of any invention, design, process, product, or device which is the subject of patent rights or copyrights held by others. If a particular invention, design, process, product, or device is specified in the Contract Documents for use in the performance of the Work and if to the actual knowledge of Owner or Engineer its use is subject to patent rights or copyrights calling for the payment of any license fee or royalty to others, the existence of such rights shall be disclosed by Owner in the Contract Documents.
- B. To the fullest extent permitted by Laws and Regulations Owner shall indemnify and hold harmless Contractor and Subcontractors, and the officers, directors, partners, employees, agents, and consultants of each and application them from and against all claims, costs, losses, and damages, including but not limited to all fees and charges of engineers, architects, attorneys, and other processionals and all court or arbitration or other dispute resolution costs arising out of crelating to any infringement of patent rights or copyrights incident to the use in the personnel ce of the Work or resulting from the incorporation in the Work of any invention, deach, process, product, or device specified in the Contract Documents, but not its attified as using subject to payment of any license fee or royalty to others required by payint he process.
- C. To the fullest extent permitted a Laws and Regulations, Contractor shall indemnify and hold harmless Owner ap Engir eer, al the officers, directors, partners, employees, agents, consultants and of each and any of them from and against all claims, costs, losses and charges (including but not limited to all fees and charges of and other professionals and all court or arbitration or engineers, archite rne) other dispute r solution c ts) arising out of or relating to any infringement of patent incident to the use in the performance of the Work or resulting from rights or copyright the Wark of any invention, design, process, product, or device not the incorporation in specified in the Contra ocuments.

6.08 Permits

A. A listing of the permit(s) known at the time of preparation of the Bid Documents to be required for the Project and the identification of the party responsible for obtaining such permit(s) is set forth in the attached Exhibit O. Owner will obtain and pay for all necessary permits which by Laws or Regulations must be obtained by the Owner. The Contractor will obtain and pay for all other permits, licenses and certificates of inspection. The Contractor will pay for all inspection costs and fees. The Owner and Engineer will assist the Contractor as required by the Permitting Agency in obtaining all permits

- required to be obtained by the Contractor. The Contractor will assist the Owner as required by the Permitting Agency in obtaining the permits required to be obtained by the Owner.
- B. The Contractor and/or his Subcontractor(s) shall obtain, complete, seal and sign all applications required to obtain construction permits required by state and local government agencies. A copy of the electrician's and plumber's current state and/or local license shall be delivered to the Owner.
- C. When required by the local governing body, the electrician and plumber will execute a mechanical bond in the form approved by the local government.
- D. If Owner is required by Laws and Regulations to apply for a building permit, all bonds, application forms and copies of licenses shall be delivered to the Owner by Contractor so these documents may be submitted with the Owner's application for a building permit. The Contractor shall assist the Owner in preparing the building permit. The Owner will pay for the building permit.

6.09 Laws and Regulations

- A. Contractor shall give all notices required and shall comply with all Laws and Regulations applicable to the performance of the Work. Except where otherwise expressly required by applicable Laws and Regulations, neither Owner nor Engineer shall be responsible for monitoring Contractor's compliance with any Laws or Regulations.
- B. If Contractor performs and Work freewing or having reason to know that is contrary to Laws or Regulations, Contractor shall bear all claims, costs, losses, and damages (including but not frame to an fees and charges of engineers, architects, attorneys, and other professionals and an could or arbitration or other dispute resolution costs) arising out of or relating to such work. However, it shall not be Contractor's responsibility to make certain that the Spraifications and Drawings are in accordance with Laws and Regulations, but this shall not relieve Contractor of Contractor's obligations under Paragraph 3.03.
- C. Changes in Laws or Regulations not known at the time of opening of Bids (or, on the Effective Date of the Agreement if there were no Bids) having an effect on the cost or time of performance of the Work shall be the subject of an adjustment in Contract Price or Contract Times. If Owner and Contractor are unable to agree on entitlement to or on the amount or extent, if any, of any such adjustment, a Claim may be made therefor as provided in Paragraph 10.05.

6.10 *Taxes*

- A. Unless otherwise provided in the Contract Documents, Contractor shall pay all sales, consumer, use, and other similar taxes required to be paid by Contractor in accordance with the Laws and Regulations of the place of the Project which are applicable during the performance of the Work.
- B. Contractor's responsibility under Paragraph 6.10 to pay all such taxes shall: (i) include the obligations to pay any interest or penalties that may be assessed as a result of Contractor's late payment or failure to pay such taxes, and (ii) survive final payment, completion and acceptance of the Work and termination or completion of the Agreement.
- C. Contractor shall indemnify and hold harmless and defend Owner from and against all claims, losses, expenses, damages and liability relating to: (i) Contractor's nonpayment of any sales, consumer, use and other similar taxes or interest or penalties required to be paid by Contractor, or (ii) Contractor's failure to utilize or implement any available sales and use tax exemption or Contractor's failure to that any necessary exemption certificate or other required exemption evidence.
- D. Contractor shall furnish evidence satisfactor to Owner that Contractor has paid all sales, consumer, use and other similar taxes recovered to be paid by Contractor. Contractor shall also furnish to Owner with Contractor's a dications for final payment a schedule of Contract has determined are entitled to sales all items incorporated in the Work to and use taxes exemption and for which no les and use taxes were paid by Contractor. Owner reserves the right to audit the or ractor's compliance with applicable sales and relea e of retainage and final payment. use taxes requirements print actor determations or exemptions or otherwise has reason disagrees with any of Cor applicable sales and use taxes, Owner shall be to believe that Contractor entitled to withhold the amount of sales and use taxes Owner believes Owner may be esult of Contractor's nonpayment until: (i) Contractor presents potentially liable & evidence satisfactory to Other that Contractor has paid the taxes in question or that the items in question are exempt and (ii) all statues of limitation for the applicable taxing authority to bring a actic against Owner for payment of the taxes in question have expired, whichever firs curs.
- E. In addition to Owner's other rights and remedies under this Paragraph 6.10, Owner shall be entitled to set off against monies otherwise due Contractor hereunder the amount of any sales and use tax, or any other tax, which Owner is required to pay be reason of Contractor's failure to comply with this Paragraph 6.10.

6.11 Use of Site and Other Areas

A. Limitation on Use of Site and Other Areas

- Contractor shall confine construction equipment, the storage of materials and equipment, and the operations of workers to the Site and other areas permitted by Laws and Regulations, and shall not unreasonably encumber the Site and other areas with construction equipment or other materials or equipment. Contractor shall assume full responsibility for any damage to any such land or area, or to the owner or occupant thereof, or of any adjacent land or areas resulting from the performance of the Work.
- 2. Should any claim be made by any such owner or occupant because of the performance of the Work, Contractor shall promptly settle with such other party by negotiation or otherwise resolve the claim by arbitration or other dispute resolution proceeding or at law.
- 3. To the fullest extent permitted by Laws and Regulations, Contractor shall indemnify and hold harmless Owner and Engineer, and the officers, directors, partners, employees, agents, consultants and subcontract is of each and any of them from and against all claims, costs, losses, and dan age; (including but not limited to all fees and charges of engineers, architects, attorneys, and other professionals and all court or arbitration or other dispute resolution costs) are ing out of or relating to any claim or action, legal or equitable, brought by any such owner or occupant against Owner, Engineer, or any other party incomplied hereunder to the extent caused by or based upon Contractor's performance on he Work.
- B. Removal of Debris During Performance of Work: During the progress of the Work, Contractor shall keep the Site and other areas free from accumulations of waste materials, rubbish, and other debris generated by the Work shall be removed from the Site. Removal and disposal of such laste. Serials, rubbish, and other debris shall conform to applicable Laws and Regulations.
- C. Cleaning: Pric to Substantial Completion of the Work, Contractor shall clean the Site and the Work and make it leady for utilization by Owner. At the completion of the Work, Contractor shall releave from the Site all tools, appliances, construction equipment and machinery, and surple materials and shall restore to original condition all property not designated for alteration by the Contract Documents.
- D. Loading Structures: Contractor shall not load nor permit any part of any structure to be loaded in any manner that will endanger the structure, nor shall Contractor subject any part of the Work or adjacent property to stresses or pressures that will endanger it.

6.12 Record Documents

A. Contractor shall maintain in a safe place at the Site one record copy of all Drawings, Specifications, Addenda, Change Orders, Work Change Directives, Field Orders, and

written interpretations and clarifications in good order and annotated to show changes made during construction. These record documents together with all approved Samples and a counterpart of all approved Shop Drawings will be available to Engineer for reference. Upon completion of the Work, Contractor shall deliver these record documents, Samples, and Shop Drawings to Engineer for Owner.

6.13 Safety and Protection

- A. Contractor shall be solely responsible for initiating, maintaining and supervising all safety precautions and programs in connection with the Work. Such responsibility does not relieve Subcontractors of their responsibility for the safety of persons or property in the performance of their work, nor for compliance with applicable safety Laws and Regulations. Contractor shall take all necessary precautions for the safety of, and shall provide the necessary protection to prevent damage, injury or loss to:
 - 1. all persons on the Site or who may be affected by the Work;
 - 2. all the Work and materials and equipment to be a corporated therein, whether in storage on or off the Site; and
 - 3. other property at the Site or adjacent thereto including trees, shrubs, lawns, walks, pavements, roadways, structures, utilities, and Underground Facilities not designated for removal, relocation, or replacement in the purse of construction.
- B. Contractor shall comply with all applicable laws and Regulations relating to the safety of persons or property, or to the precision of persons or property from damage, injury, or loss; and shall erect are maintain as necessary safeguards for such safety and protection. Contractor stall no protection of adjacent property and of Underground Facilities and other utility of the work may affect them, and shall cooperate with the protection, removal, relocation, and replacement of their property.
- C. All damage, injury, or loss of any property referred to in Paragraph 6.13.A.2 or 6.13.A.3 caused, directly or indirectly, in whole or in part, by Contractor, any Subcontractor, Supplier, or any other Individual or entity directly or indirectly employed by any of them to perform any of the Work, or anyone for whose acts any of them may be liable, shall be remedied by Contractor (except damage or loss attributable to the fault of Drawings or Specifications or to the acts or omissions of Owner or Engineer or anyone employed by any of them, or anyone for whose acts any of them may be liable, and not attributable, directly or indirectly, in whole or in part, to the fault or negligence of Contractor or any Subcontractor, Supplier, or other individual or entity directly or indirectly employed by any of them).

D. Contractor's duties and responsibilities for safety and for protection of the Work shall continue until such time as all the Work is completed and Engineer has issued a notice to Owner and Contractor in accordance with Paragraph 14.07.B that the Work is acceptable (except as otherwise expressly provided in connection with Substantial Completion).

6.14 Safety Representative

A. Contractor shall designate a qualified and experienced safety representative at the Site whose duties and responsibilities shall be the prevention of accidents and the maintaining and supervising of safety precautions and programs.

6.15 Emergencies

A. In emergencies affecting the safety or protection of persons or the Work or property at the Site or adjacent thereto, Contractor is obligated to act to prevent threatened damage, injury, or loss. Contractor shall give Engineer prompt youten notice if Contractor believes that any significant changes in the Work or variations from the Contract Documents have been caused thereby or are required as a result nerect of Engineer determines that a change in the Contract Documents is required accause of the action taken by Contractor in response to such an emergency, a Work Change Directive or Change Order will be issued.

6.16 Shop Drawings and Samples

A. Contractor shall submit Shop Drawing and San les to Engineer for review and approval in accordance with the accordance Solution of Submittals (as required by Paragraph 2.05). Each submittal will be identified as Engineer may require.

1. Shop Drawings

- a. Submit Lamber of topic specified by Engineer.
- b. Data shown on the Shop Drawings will be complete with respect to quantities, dimensions, specified performance and design criteria, materials, and similar data to show Engineer the services, materials, and equipment Contractor proposes to provide and to enable Engineer to review the information for the limited purposes required by Paragraph 6.16.D.
- Samples: Contractor shall also submit Samples to Engineer for review and approval in accordance with the acceptable schedule of Shop Drawings and Sample submittals.
 - a. Submit number of Samples specified in the Specifications.

- b. Clearly identify each Sample as to material, Supplier, pertinent data such as catalog numbers, the use for which intended and other data as Engineer may require to enable Engineer to review the submittal for the limited purposes required by Paragraph 6.16.D.
- B. Where a Shop Drawing or Sample is required by the Contract Documents or the Schedule of Submittals, any related Work performed prior to Engineer's review and approval of the pertinent submittal will be at the Contractor's risk; no Change Order will be issued to provide additional time or compensation for corrections needed to conform previously performed work to the Shop Drawing or Sample approved by the Engineer.

C. Submittal Procedures

- 1. Before submitting each Shop Drawing or Sample, Contractor shall have:
 - a. reviewed and coordinated each Shop Drawing or Sample with other Shop Drawings and Samples and with the requirements of the Work and the Contract Documents.
 - b. determined and verified all field mer drements, quantities, dimensions, specified performance and design criteria, stall don requirements, materials, catalog numbers, and similar information with spect thereto;
 - c. determined and verified the sum litty of all materials offered with respect to intended use, fabrication, ship increasing, storage, assembly, and installation pertaining to the performance can't Work;
 - d. determined and erified displayment in relative to Contractor's responsibilities for means, methods, raniques, sequences, and procedures of construction, and safety pressures and programs incident thereto.
- 2. Each subnitial shall be r a stamp or specific written certification that Contractor has satisfied Contractor's oligations under the Contract Documents with respect to Contractor's review and approval of that submittal.
- 3. With each submittal, Contractor shall give Engineer specific written notice of any variations, that the Shop Drawing or Sample may have from the requirements of the Contract Documents. This notice shall be both a written communication separate from the Shop Drawings or Sample submittal; and, in addition, by a specific notation made on each Shop Drawing or Sample submitted to Engineer for review and approval of each such variation.

D. Engineer's Review

- 1. Engineer will provide timely review of Shop Drawings and Samples in accordance with the Schedule of Submittals approved pursuant to Paragraph 2.05. Engineer's review and approval will be only to determine if the items covered by the submittals will, after installation or incorporation in the Work, conform to the information given in the Contract Documents and be compatible with the design concept of the completed Project as a functioning whole as indicated by the Contract Documents.
- 2. Engineer's review and approval will not extend to means, methods, techniques, sequences, or procedures of construction (except where a particular means, method, technique, sequence, or procedure of construction is specifically and expressly called for by the Contract Documents) or to safety precautions or programs incident thereto. The review and approval of a separate item as such will not indicate approval of the assembly in which the item functions.
- 3. Engineer's review and approval shall not relieve Contractor from responsibility for any variation from the requirements of the Contract Documents unless Contractor has complied with the requirements of Paragraph \$16.C.3 and Engineer has given written approval of each such variation by specific written notation thereof incorporated in or accompanying the Shap Drawing of Sample. Engineer's review and approval shall not relieve Contractor from responsibility for complying with the requirements of Paragraph 6.16.C.1.

E. Resubmittal Procedures

- 1. Contractor shall make corrections expired by Engineer and shall return the required number of corrected correst. Shop grawings and submit, as required, new Samples for review and approval. Contractor shall direct specific attention in writing to revisions other than its correct shall direct provides a submittals.
- F. Contractor shall for ish sequiled submittals with sufficient information and accuracy in order to obtain a quired approval of an item with no more than three submittals. Engineer will record Engineer's time for reviewing subsequent submittals of Shop Drawings, samples or other terms requiring approval and Contractor shall reimburse Owner for Engineer's charges for ach time.

6.17 Continuing the Work

A. Contractor shall carry on the Work and adhere to the Progress Schedule during all disputes or disagreements with Owner. No Work shall be delayed or postponed pending resolution of any disputes or disagreements, except as permitted by Paragraph 15.04 or as Owner and Contractor may otherwise agree in writing.

6.18 Contractor's General Warranty and Guarantee

- A. Contractor warrants and guarantees to Owner that all Work will be in accordance with the Contract Documents and will not be defective. Engineer and its Related Entities shall be entitled to rely on Contractor's warranty and guarantee.
- B. Contractor's warranty and guarantee hereunder excludes defects or damage caused by:
 - abuse, modification, or improper maintenance or operation by persons other than Contractor, Subcontractors, Suppliers, or any other individual or entity for whom Contractor is responsible; or
 - 2. normal wear and tear under normal usage.
- C. Contractor's obligation to perform and complete the Work in accordance with the Contract Documents shall be absolute. None of the following will constitute an acceptance of Work that is not in accordance with the Contract Documents or a release of Contractor's obligation to perform the Work in accordance with the Contract Documents:
 - 1. observations by Engineer;
 - 2. recommendation by Engineer or payment a Owner of any progress or final payment;
 - 3. the issuance of a certificate of lubs stial Completion by Engineer or any payment related thereto by Owner;
 - 4. use or occupancy of the vol. or an epart thereof by Owner;
 - 5. any review and approval of Shop Lawing or Sample submittal or the issuance of a notice of acceptability. Signeer,
 - 6. any inspection test, rap, aval by others; or
 - 7. any correction of defective Work by Owner.

6.19 Indemnification

A. To the fullest extent permitted by Laws and Regulations, Contractor shall indemnify and hold harmless Owner and Engineer, and the officers, directors, partners, employees, agents, consultants and subcontractors of each and any of them from and against all claims, costs, losses, and damages (including but not limited to all fees and charges of engineers, architects, attorneys, and other professionals and all court or arbitration or other dispute resolution costs) arising out of, in connection with, or relating to the performance of the Work, provided that any such claim, cost, loss, or damage is attributable to bodily injury, sickness, disease, or death, or to injury to or destruction of tangible property (other than the Work itself), including the loss of use resulting therefrom but only to the extent caused by any negligent act or omission of Contractor, any

Subcontractor, any Supplier, or any individual or entity directly or indirectly employed by any of them to perform any of the Work or anyone for whose acts any of them may be liable. Contractor's obligations under this Section 6.19 shall not be limited to or by the amount of insurance coverage required by the Contract Documents.

- B. In any and all claims against Owner or Engineer or any of their respective consultants, agents, officers, directors, partners, or employees by any employee (or the survivor or personal representative of such employee) of Contractor, any Subcontractor, any Supplier, or any individual or entity directly or indirectly employed by any of them to perform any of the Work, or anyone for whose acts any of them may be liable, the indemnification obligation under Paragraph 6.19.A shall not be limited in any way by any limitation on the amount or type of damages, compensation, or benefits payable by or for Contractor or any such Subcontractor, Supplier, or other individual or entity under workers' compensation acts, disability benefit acts, or other employee benefit acts.
- C. The indemnification obligations of Contractor under P agraph 6.19.A shall not extend to the liability of Engineer and Engineer's officers, direct s, partners, employees, agents, consultants and subcontractors arising out of:
 - 1. the preparation or approval of, or the father to prepare of approve, maps, Drawings, opinions, reports, surveys, Change Orders, designs, or Specifications; or
 - 2. giving directions or instructions, failing to see them, if that is the primary cause of the injury or damage.

6.20 Delegation of Professional Degan ervice

- A. Contractor will not be a quirer to a roude professional design services unless such services are specifically required by the Contract Documents for a portion of the Work or unless such services are quired to carry out Contractor's responsibilities for construction means, methods, to hniques, sequences, and procedures. Contractor shall not be required to provide professional services in violation of applicable law.
- B. If professional designativices or certifications by a design professional related to systems, materials or equipment are specifically required of Contractor by the Contract Documents, Owner and Engineer will specify all performance and design criteria that such services must satisfy. Contractor shall cause such services or certifications to be provided by a properly licensed professional, whose signature and seal shall appear on all drawings, calculations, specifications, certifications, Shop Drawings and other submittals prepared by such professional. Shop Drawings and other submittals related to the Work designed or certified by such professional, if prepared by others, shall bear such professional's written approval when submitted to Engineer.

- C. Owner and Engineer shall be entitled to rely upon the adequacy, accuracy and completeness of the services, certifications or approvals performed by such design professionals, provided Owner and Engineer have specified to Contractor all performance and design criteria that such services must satisfy.
- D. Pursuant to this Paragraph 6.20, Engineer's review and approval of design calculations and design drawings will be only for the limited purpose of checking for conformance with performance and design criteria given and the design concept expressed in the Contract Documents. Engineer's review and approval of Shop Drawings and other submittals (except design calculations and design drawings) will be only for the purpose stated in Paragraph 6.16.D.1.
- E. Contractor shall not be responsible for the adequacy of the performance or design criteria required by the Contract Documents.

ARTICLE 7 - OTHER WORK AT THE SITE

7.01 Related Work at Site

- A. Owner may perform other work related to the Project at the SNE with Owner's employees, or via other direct contracts therefor, or have other work performed by utility owners. If such other work is not noted in the Contract Decements, then:
 - 1. written notice thereof will be give to stracts prior to starting any such other work; and
 - 2. if Owner and Contract of are mable to agree on entitlement to or on the amount or extent, if any, of any adjustment in the Contract Price or Contract Times that should be allowed as a result to ach other work, a Claim may be made therefor as provided in Paragraph 1....
- B. Contractor shall afford each other contractor who is a party to such a direct contract, each utility owner and own, if Owner is performing other work with Owner's employees, proper and safe access the Site, a reasonable opportunity for the introduction and storage of materials and equipment and the execution of such other work, and shall properly coordinate the Work with theirs. Contractor shall do all cutting, fitting, and patching of the Work that may be required to properly connect or otherwise make its several parts come together and properly integrate with such other work. Contractor shall not endanger any work of others by cutting, excavating, or otherwise altering their work and will only cut or alter their work with the written consent of Engineer and the others whose work will be affected. The duties and responsibilities of Contractor under this Paragraph are for the benefit of such utility owners and other contractors to the extent that there are comparable provisions for the benefit of Contractor in said direct contracts between Owner and such utility owners and other contractors.

C. If the proper execution or results of any part of Contractor's Work depends upon work performed by others under this Article 7, Contractor shall inspect such other work and promptly report to Engineer in writing any delays, defects, or deficiencies in such other work that render it unavailable or unsuitable for the proper execution and results of Contractor's Work. Contractor's failure to so report will constitute an acceptance of such other work as fit and proper for integration with Contractor's Work except for latent defects and deficiencies in such other work.

7.02 Coordination

- A. If Owner intends to contract with others for the performance of other work on the Project at the Site, the following will be agreed to at the Preconstruction Conference:
 - 1. the individual or entity who will have authority and responsibility for coordination of the activities among the various contractors will be identified;
 - 2. the specific matters to be covered by such thority and responsibility will be itemized; and
 - 3. the extent of such authority and responsibilities will be provided.
- B. Unless otherwise provided in the Contract Doments, Owner shall have sole authority and responsibility for such coordination.

ARTICLE 8 - OWNER'S RESPONSIBILITIES

- 8.01 Communications to Contract
 - A. Except as otherwise provide in these General Conditions, Owner shall issue all communications to a tracte through Engineer.
- 8.02 Replacement of Signeer
 - A. In case of termination of the employment of Engineer, Owner shall appoint an engineer whose status under the contract Documents shall be that of the former Engineer.
- 8.03 Furnish Data
 - A. Owner shall promptly furnish the data required of Owner under the Contract Documents.
- 8.04 Pay When Due
 - A. Owner shall make payments to Contractor when they are due as provided in Paragraphs 14.02.C and 14.07.C.

8.05 Lands and Easements; Reports and Tests

A. Owner's duties in respect of providing lands and easements and providing engineering surveys to establish reference points are set forth in Paragraphs 4.01 and 4.05. Paragraph 4.02 refers to Owner's identifying and making available to Contractor copies of reports of explorations and tests of subsurface conditions and drawings of physical conditions in or relating to existing surface or subsurface structures at or contiguous to the Site that have been utilized by Engineer in preparing the Contract Documents.

8.06 Limitations on Owner's Responsibilities

A. The Owner shall not supervise, direct, or have control or authority over, nor be responsible for, Contractor's means, methods, techniques, sequences, or procedures of construction, or the safety precautions and programs incident thereto, or for any failure of Contractor to comply with Laws and Regulations applicable to the performance of the Work. Owner will not be responsible for Contractor failure to perform the Work in accordance with the Contract Documents.

8.07 Compliance with Safety Program

A. While at the Site, Owner and its employed and epresentatives shall become familiar with Contractor's safety programs as initiated a maintained under Paragraph 6.13 and shall comply with the requirements of such programs while at the Site.

ARTICLE 9 - ENGINEER'S STATUS DURING CO. STATICTION

9.01 Owner's Representative

- A. Engineer will be Owner's it recentative during the construction period.
- B. Owner reserves the right part by time, and in Owner's sole discretion to: 1) designate an employee of Owner or a Owner-affiliated entity as Engineer, 2) directly undertake or perform some or a Engine r's authority, duties, or responsibilities, and 3) retain Owner-affiliated entities or in leps dent engineers, consultants, or managers to undertake some or all of Engineer's of Owner's authority, duties or responsibilities under the Contract Documents.
- C. The assignment of any authority, duties or responsibilities to Engineer or others under the Contract Documents, or any undertaking, exercise or performance thereof by Engineer, Owner, or others is intended to be for the sole and exclusive benefit of Owner and not for the benefit of Contractor, Subcontractor, Supplier, or any other person or organization.

9.02 Visits to Site

- A. Engineer will make visits to the Site at intervals appropriate to the various stages of construction as Engineer deems necessary in order to observe as an experienced and qualified design professional the progress that has been made and the quality of the various aspects of Contractor's executed Work. Based on information obtained during such visits and observations, Engineer, for the benefit of Owner, will determine, in general, if the Work is proceeding in accordance with the Contract Documents. Engineer will not be required to make exhaustive or continuous inspections on the Site to check the quality or quantity of the Work. Engineer's efforts will be directed toward providing for Owner a greater degree of confidence that the completed Work will conform generally to the Contract Documents. On the basis of such visits and observations, Engineer will keep Owner informed of the progress of the Work and will endeavor to guard Owner against defective Work.
- B. Engineer's visits and observations are subject to all the amitations on Engineer's authority and responsibility set forth in Paragraph 9.07. An sularly, but without limiting the foregoing, during or as a result of Engineer's visits or observations of Contractor's Work, Engineer will not supervise, direct, control, or have authors over or be responsible for Contractor's means, methods, techniques, equentes, or procedures of construction, or the safety precautions and programs incident the reto, or for any failure of Contractor to comply with Laws and Regulations applicable to the performance of the Work.

9.03 Authorized Variations in Work

ariatics in the Work from the requirements of the A. Engineer may authorize magnetic magn 7 do n e an adjustment in the Contract Price or the Contract Documents whi t invol Contract Times and are the design concept of the completed Project as a functioning whole as indical by the Contract Documents. These may be accomplished e bli by a Field Order ling on Owner and also on Contractor, who shall perform the Work involved promptly If Owner or Contractor believes that a Field Order justifies an adjustment in the Contract I ice or Contract Times, or both, and the parties are unable to agree on entitlement to o on the amount or extent, if any, of any such adjustment, a for as provided in Paragraph 10.05. Claim may be made the

9.04 Rejecting Defective Work

A. Engineer will have authority to reject Work which Engineer believes to be defective, or that Engineer believes will not produce a completed Project that conforms to the Contract Documents or that will prejudice the integrity of the design concept of the completed Project as a functioning whole as indicated by the Contract Documents. Engineer will also have authority to require inspection or testing of the Work as provided in Paragraph 13.03, whether or not the Work is fabricated, installed, or completed.

9.05 Determinations for Unit Price Work

A. Engineer will determine the actual quantities and classifications of Unit Price Work performed by Contractor. Engineer will review with Contractor the Engineer's preliminary determinations on such matters before rendering a written decision thereon (by recommendation of an Application for Payment or otherwise). Engineer's written decision thereon will be final and binding (except as modified by Engineer to reflect changed factual conditions or more accurate data) upon Owner and Contractor, subject to the provisions of Paragraph 10.05.

9.06 Decisions on Requirements of Contract Documents and Acceptability of Work

- A. Engineer will be the initial interpreter of the requirements of the Contract Documents and judge of the acceptability of the Work thereunder. All matters in question and other matters between Owner and Contractor arising prior to the date final payment is due relating to the acceptability of the Work, and the interpretation of the requirements of the Contract Documents pertaining to the performance are Work, will be referred initially to Engineer in writing within 30 days of the event giving rise. The question.
- B. Engineer will, with reasonable promptness, render a written decision on the issue referred. If Owner or Contractor believes at any such decision entitles them to an adjustment in the Contract Price or Contract Notes or both, a Claim may be made under Paragraph 10.05. For the purpose of determining the timeliness of a Claim under Paragraph 10.05.A, the date of Engineer's prisjon under this Paragraph 9.06.B shall be the date of the event giving rise to the laid.
- C. Engineer's written decisio on the issue eferred will be final and binding on Owner and Contractor, subject to the rovision of Paragraph 10.05.
- D. When functioning a majoret and judge under this Paragraph 9.06, Engineer will not show partiality. Owner or Coutractor and will not be liable in connection with any interpretation of accision relatered in good faith in such capacity.

9.07 Limitations on Engineer Lathority and Responsibilities

A. Neither Engineer's authority or responsibility under this Article 9 or under any other provision of the Contract Documents nor any decision made by Engineer in good faith either to exercise or not exercise such authority or responsibility or the undertaking, exercise, or performance of any authority or responsibility by Engineer shall create, impose, or give rise to any duty in contract, tort, or otherwise owed by Engineer to Contractor, any Subcontractor, any Supplier, any other individual or entity, or to any surety for or employee or agent of any of them.

- B. Engineer will not supervise, direct, control, or have authority over or be responsible for Contractor's means, methods, techniques, sequences, or procedures of construction, or the safety precautions and programs incident thereto, or for any failure of Contractor to comply with Laws and Regulations applicable to the performance of the Work. Engineer will not be responsible for Contractor's failure to perform the Work in accordance with the Contract Documents.
- C. Engineer will not be responsible for the acts or omissions of Contractor or of any Subcontractor, any Supplier, or of any other individual or entity performing any of the Work.
- D. Engineer's review of the final Application for Payment and accompanying documentation and all maintenance and operating instructions, schedules, guarantees, bonds, certificates of inspection, tests and approvals, and other documentation required to be delivered by Paragraph 14.07.A will only be to determine generally that their content complies with the requirements of, and in the case certificates of inspections, tests, and approvals that the results certified indicate compliance with the Contract Documents.
- E. The limitations upon authority and responsibility set forth in this Paragraph 9.07 shall also apply to the Resident Project Representative of any and assistants, if any.

ARTICLE 10 - CHANGES IN THE WORK; CLAIMS

10.01 Authorized Changes in the Work

- A. Without invalidating the Copton and amout notice to any surety, Owner may, at any time or from time to time order addition, deletions, or revisions in the Work by a Work Change Directive. Upon a ceipt a resum document, Contractor shall promptly proceed with the Work involved what will be performed under the applicable conditions of the Contract Documents (carept a otherwise specifically provided).
- B. If Owner and Contractor are unable to agree on entitlement to, or on the amount or extent, if any, of a adjustment in the Contract Price or Contract Times, or both, that should be allowed as a result of a Work Change Directive, a Claim may be made therefor as provided in Paragraph 10.05.

10.02 Unauthorized Changes in the Work

A. Contractor shall not be entitled to an increase in the Contract Price or an extension of the Contract Times with respect to any work performed that is not required by the Contract Documents as modified in accordance with Paragraph 3.04, except in the case of an emergency as provided in Paragraph 6.15 or in the case of uncovering Work as provided in Paragraph 13.04.B.

10.03 Execution of Change Orders

- A. Owner and Contractor shall execute appropriate Change Orders recommended by Engineer covering:
 - changes in the Work which are: (i) ordered by Owner pursuant to Paragraph 10.01.A, (ii) required because of acceptance of defective Work under Paragraph 13.08.A or Owner's correction of defective Work under Paragraph 13.09, or (iii) agreed to by the parties;
 - 2. changes in the Contract Price or Contract Times which are agreed to by the parties, including any undisputed sum or amount of time for Work actually performed in accordance with a Work Change Directive; and
 - 3. changes in the Contract Price or Contract Times which embody the substance of any written decision rendered by Engineer pursuant to aragraph 10.05; provided that, in lieu of executing any such Change Order, an a seal may be taken from any such decision in accordance with the provisions of the Contract Documents and applicable Laws and Regulations, but during any such appeal, contractor shall carry on the Work and adhere to the Progress Schedule as provided in Paragraph 6.17.A.

10.04 Notification to Surety

A. If notice of any change affecting the tensor scope of the Work or the provisions of the Contract Documents (including, but not limited), Contract Price or Contract Times) is required by the provisions of the bond to be given to a surety, the giving of any such notice will be Contractor's responsibility. The amount of each applicable bond will be adjusted to reflect the effect of a proper change.

10.05 Claims

A. Notice: Written otice stating the general nature of each Claim shall be delivered by the claimant to Engineer and the other party to the Contract promptly (but in no event later than 30 days) after the start of the event giving rise thereto. The responsibility to substantiate a Claim shall rest with the party making the Claim. Notice of the amount or extent of the Claim, with supporting data shall be delivered to the Engineer and the other party to the Contract within 60 days after the start of such event. A Claim for an adjustment in Contract Price shall be prepared in accordance with the provisions of Paragraph 12.01.B. A Claim for an adjustment in Contract Times shall be prepared in accordance with the provisions of Paragraph 12.02.B. Each Claim shall be accompanied by claimant's written statement that the adjustment claimed is the entire adjustment to which the claimant believes it is entitled as a result of said event. The opposing party shall submit any response to Engineer and the claimant within 30 days after receipt of the claimant's last submittal.

- B. Other Party's Action: The other party will review each Claim and, within 30 days after receipt of the last submittal of the claimant or the last submittal of the opposing party, if any, take one of the following actions in writing:
 - 1. deny the Claim in whole or in part, or
 - 2. approve the Claim.
- C. In the event that the other party does not take action on a Claim within said 30 days, the Claim shall be deemed denied.
- D. The other party's written action under Paragraph 10.05.B or denial pursuant to Paragraph 10.05.C will be final and binding upon the claimant, Owner and Contractor, unless claimant invokes the dispute resolution procedure set forth in Article 16 within 30 days of such action or denial.
- E. No Claim for an adjustment in Contract Price or antract Times will be valid if not submitted in accordance with this Paragraph 10.05

ARTICLE 11 - COST OF THE WORK; ALLOWANCES; UNIT PRICE WORK

11.01 Cost of the Work

- A. Costs Included: The term Cost of the library means the sum of all costs, except those excluded in Paragraph 11.01.B, necessarily included and paid by Contractor in the proper performance of the Work. When the value of any Work covered by a Change Order or when a Claim for an adjustment. Contract Price is determined on the basis of Cost of the Work, the costs to be reincursed. Contractor will be only those additional or incremental costs required to ause of the change in the Work or because of the event giving rise to the Chantacter ause of the ause of the agreed to in writing by Owner, such costs shall be in amounts to hather than those prevailing in the locality of the Project, shall include on the following items, and shall not include any of the costs itemized in Paragraph 11.01.
 - 1. Payroll costs for exployees in the direct employ of Contractor in the performance of the Work under schedules of job classifications agreed upon by Owner and Contractor. Such employees shall include, without limitation, superintendents, foremen, and other personnel employed full time on the Work. Payroll costs for employees not employed full time on the Work shall be apportioned on the basis of their time spent on the Work. Payroll costs shall include, but not be limited to, salaries and wages plus the cost of fringe benefits, which shall include social security contributions, unemployment, excise, and payroll taxes, workers' compensation, health and retirement benefits, bonuses, sick leave, vacation and holiday pay applicable thereto. The expenses of performing Work outside of regular working

- hours, on Saturday, Sunday, or legal holidays, shall be included in the above to the extent authorized by Owner.
- 2. Cost of all materials and equipment furnished and incorporated in the Work, including costs of transportation and storage thereof, and Suppliers' field services required in connection therewith. All cash discounts shall accrue to Contractor unless Owner deposits funds with Contractor with which to make payments, in which case the cash discounts shall accrue to Owner. All trade discounts, rebates and refunds and returns from sale of surplus materials and equipment shall accrue to Owner, and Contractor shall make provisions so that they may be obtained.
- 3. Payments made by Contractor to Subcontractors for Work performed by Subcontractors. If required by Owner, Contractor shall obtain competitive bids from subcontractors acceptable to Owner and Contractor and shall deliver such bids to Owner, who will then determine, with the advice of Engineer, which bids, if any, will be acceptable. If any subcontract provides that the Subcontractor is to be paid on the basis of Cost of the Work plus a fee, the Subcontractor's Cost of the Work and fee shall be determined in the same manner as Contractor's Cost of the Work and fee as provided in this Paragraph 11.01.
- 4. Costs of special consultants (including by no limited to Engineers, architects, testing laboratories, surveyors, attorneys, and accountants) employed for services specifically related to the Work.
- 5. Supplemental costs including the following:
 - a. The proportion of access by transportation, travel, and subsistence expenses of Contractor's employees and in discharge of duties connected with the Work.
 - b. Cost, including transportation and maintenance, of all materials, supplies, equipment, machinery, appliances, office, and temporary facilities at the Site, and hand tools not owned by the workers, which are consumed in the performance of the Work, and cost, less market value, of such items used but not consume which remain the property of Contractor.
 - c. Rentals of all construction equipment and machinery, and the parts thereof whether rented from Contractor or others in accordance with rental agreements approved by Owner with the advice of Engineer, and the costs of transportation, loading, unloading, assembly, dismantling, and removal thereof. All such costs shall be in accordance with the terms of said rental agreements. The rental of any such equipment, machinery, or parts shall cease when the use thereof is no longer necessary for the Work.

- d. Sales, consumer, use, and other similar taxes related to the Work, and for which Contractor is liable, imposed by Laws and Regulations.
- e. Deposits lost for causes other than negligence of Contractor, any Subcontractor, or anyone directly or indirectly employed by any of them or for whose acts any of them may be liable, and royalty payments and fees for permits and licenses.
- f. Losses and damages (and related expenses) caused by damage to the Work, not compensated by insurance or otherwise, sustained by Contractor in connection with the performance of the Work (except losses and damages within the deductible amounts of property insurance established in accordance with Paragraph 5.06), provided such losses and damages have resulted from causes other than the negligence of Contractor, any Subcontractor, or anyone directly or indirectly employed by any of them or for whose acts any of them may be liable. Such losses shall include settlements made with the written consent and approval of Owner. No such losses, damage, and expenses shall be included in the Cost of the Work for the purpose of disconining Contractor's fee.
- g. The cost of utilities, fuel, and sanitary acilities at the Site.
- h. Minor expenses such as telegrand lor, distance telephone calls, telephone service at the Site, expresses, and so dar petty cash items in connection with the Work.
- i. The costs of premiums for all opes and insurance Contractor is required by the Contract Document and Irchaid and maintain.
- B. Costs Excluded. The ten Cost with Work shall not include any of the following items:
 - 1. Payroll costs and their compensation of Contractor's officers, executives, principals (of partners ups and ple coprietorships), general managers, safety managers, engineers, architects, estimators, attorneys, auditors, accountants, purchasing and contracting agents, excediters, timekeepers, clerks, and other personnel employed by Contractor, weather at the Site or in Contractor's principal or branch office, for general administration of the Work and not specifically included in the agreed upon schedule of job classifications referred to in Paragraph 11.01.A.1 or not specifically covered by Paragraph 11.01.A.4, all of which are to be considered administrative costs covered by the Contractor's fee.
 - 2. Expenses of Contractor's principal and branch offices other than Contractor's office at the Site.
 - 3. Any part of Contractor's capital expenses, including interest on Contractor's capital employed for the Work and charges against Contractor for delinquent payments.

- 4. Costs due to the negligence of Contractor, any Subcontractor, or anyone directly or indirectly employed by any of them or for whose acts any of them may be liable, including but not limited to, the correction of defective Work, disposal of materials or equipment wrongly supplied, and making good any damage to property.
- 5. Other overhead or general expense costs of any kind and the costs of any item not specifically and expressly included in Paragraphs 11.01.A and 11.01.B.
- C. Contractor's Fee: When all the Work is performed on the basis of cost-plus, Contractor's fee shall be determined as set forth in the Agreement. When the value of any Work covered by a Change Order or when a Claim for an adjustment in Contract Price is determined on the basis of Cost of the Work, Contractor's fee shall be determined as set forth in Paragraph 12.01.C.
- D. Documentation: Whenever the Cost of the Work for any purpose is to be determined pursuant to Paragraphs 11.01.A and 11.01.B, Contactor will establish and maintain records thereof in accordance with generally accept a scounting practices and submit in a form acceptable to Engineer an itemized cost breakdow together with supporting data.

11.02 Allowances

A. The Contract Price includes all allowance dentified in the Contract Documents. Contractor shall cause the Work covared by such allowances, if any, to be performed for such sums and by such persons in entities as may be acceptable to Owner and Engineer. Contract is not entitled to an enti

B. Cash Allowances

- Contractor agrees that
 - a. cash all vance include the cost to Contractor (less any applicable trade discours) of marrials and equipment required by the allowances to be delivered at the Site and all applicable taxes; and
 - b. cash allowant do not include Contractor's costs for unloading and handling on the Site, labor, installation, overhead, profit, or other expenses related to the Work covered by the cash allowances, all of which have been included separately in the Contract Price and not in the allowances, and no demand for additional payment on account of any of the foregoing will be valid.

C. Contingency Allowance

 Contractor agrees that a contingency allowance, if any, is for the sole use of Owner to cover unanticipated costs. Expenditures from the contingency allowance, if any, are authorized and valued changes in the Work in accordance with Articles 10 and

- 12. Owner shall determine which changes in the Work, if any, are paid from the contingency allowance.
- D. Prior to final payment, if applicable, an appropriate Change Order will be issued as recommended by Engineer to reflect actual amounts due Contractor on account of Work covered by allowances, and the Contract Price shall be correspondingly adjusted.

11.03 Unit Price Work

- A. Where the Contract Documents provide that all or part of the Work is to be Unit Price Work, initially the Contract Price will be deemed to include for all Unit Price Work an amount equal to the sum of the unit price for each separately identified item of Unit Price Work times the estimated quantity of each item as indicated in the Agreement.
- B. The estimated quantities of items of Unit Price Work are not guaranteed and are solely for the purpose of comparison of Bids and determining an initial Contract Price. Determinations of the actual quantities and classifications of Unit Price Work performed by Contractor will be made by Engineer subject to the practicions of Paragraph 9.05.
- C. Each unit price will be deemed to include an amount considered by Contractor to be adequate to cover Contractor's overhead and profit or each separately identified item.
- D. Owner or Contractor may make a Claim for adjustment in the Contract Price in accordance with Paragraph 10.05 if:
 - 1. the quantity of any item of the Price Work performed by Contractor differs materially and significantly from the estimated pantity of such item indicated in the Agreement; and
 - 2. there is no corrections diustment with respect to any other item of Work; and
 - 3. Contractor elieves the Contractor is entitled to an increase in Contract Price as a result of having incurre additional expense or Owner believes that Owner is entitled to a decrease in Contract Price and the parties are unable to agree as to the amount of any such increase or decrease.

ARTICLE 12 – CHANGE OF CONTRACT PRICE; CHANGE OF CONTRACT TIMES

12.01 Change of Contract Price

A. The Contract Price may only be changed by a Change Order. Any Claim for an adjustment in the Contract Price shall be based on written notice submitted by the party making the Claim to the Engineer and the other party to the Contract in accordance with the provisions of Paragraph 10.05.

- B. The value of any Work covered by a Change Order or of any Claim for an adjustment in the Contract Price will be determined as follows:
 - 1. where the Work involved is covered by unit prices contained in the Contract Documents, by application of such unit prices to the quantities of the items involved (subject to the provisions of Paragraph 11.03); or
 - 2. where the Work involved is not covered by unit prices contained in the Contract Documents, by a mutually agreed lump sum (which may include an allowance for overhead and profit not necessarily in accordance with Paragraph 12.01.C.2); or
 - 3. where the Work involved is not covered by unit prices contained in the Contract Documents and agreement to a lump sum is not reached under Paragraph 12.01.B.2, on the basis of the Cost of the Work (determined as provided in Paragraph 11.01) plus a Contractor's fee for overhead and profit (determined as provided in Paragraph 12.01.C).
- C. Contractor's Fee: The Contractor's fee for overhead as profit shall be determined as follows:
 - 1. a mutually acceptable fixed fee; or
 - 2. if a fixed fee is not agreed upon then a harbased on the following percentages of the various portions of the Cost was Work:
 - a. for costs incurred under Para rachs 11.01.A.1 and 11.01.A.2, the Contractor's fee shall be 15 percent;
 - b. for costs incurred and 1 a. ph 11.01.A.3, the Contractor's fee shall be five percent;
 - c. where he or more tiers of subcontracts are on the basis of Cost of the Work plus a it and no fitted fee is agreed upon, the intent of Paragraph 12.01.C.2.a is that the subconfactor who actually performs the Work, at whatever tier, will be paid a fee of 5 percent of the costs incurred by such Subcontractor under Paragraphs 11.01.A.1 and 11.01.A.2 and that any higher tier Subcontractor and Contractor will each be paid a fee of five percent of the amount paid to the next lower tier Subcontractor:
 - d. no fee shall be payable on the basis of costs itemized under Paragraphs 11.01.A.4, 11.01.A.5, and 11.01.B;
 - e. the amount of credit to be allowed by Contractor to Owner for any change which
 results in a net decrease in cost will be the amount of the actual net decrease in
 cost; and

f. when both additions and credits are involved in any one change, the adjustment in Contractor's fee shall be computed on the basis of the net change in accordance with Paragraphs 12.01.C.2.a through 12.01.C.2.e, inclusive.

12.02 Change of Contract Times

- A. The Contract Times may only be changed by a Change Order. Any Claim for an adjustment in the Contract Times shall be based on written notice submitted by the party making the Claim to the Engineer and the other party to the Contract in accordance with the provisions of Paragraph 10.05.
- B. Any adjustment of the Contract Times covered by a Change Order or any Claim for an adjustment in the Contract Times will be determined in accordance with the provisions of this Article 12.

12.03 Delays

- A. Where Contractor is prevented from completing any pain of the Work within the Contract Times due to delay beyond the control of Contractor, the Contract Times will be extended in an amount equal to the time lost due to such delay if a Claim is made therefor as provided in Paragraph 12.02.A. Delays beyond the control of Contractor shall include, but not be limited to, acts or neglect by Owner, as or neglect of utility owners or other contractors performing other work as contemplated by Article 7, fires, floods, epidemics, abnormal weather conditions, or acts of Ge
- B. If Owner, Engineer, or other contractors of utility owners performing other work for Owner as contemplated by Article 1, or a yone or whom Owner is responsible, delays, disrupts, or interferes with the parformance of progress of the Work, then Contractor shall be entitled to an equitable adjustment in the Contract Price or the Contract Times, or both. Contractor's entitlement of an equitable and djustment of the Contract Times is conditioned on such adjustment being essent to contractor's ability to complete the Work within the Contract Times.
- C. If Contractor is delayed in the performance or progress of the Work by fire, flood, epidemic, abnormal weather conditions, acts of God, acts or failures to act of utility owners not under the control of Owner, or other causes not the fault of and beyond control of Owner and Contractor, then Contractor shall be entitled to an equitable adjustment in Contract Times, if such adjustment is essential to Contractor's ability to complete the Work within the Contract Times. Such an adjustment shall be Contractor's sole and exclusive remedy for the delays described in this Paragraph 12.03.C.
- D. Owner, Engineer and the Related Entities of each of them shall not be liable to Contractor for any claims, costs, losses, or damages (including but not limited to all fees and charges of Engineers, architects, attorneys, and other professionals and all court or

- arbitration or other dispute resolution costs) sustained by Contractor on or in connection with any other project or anticipated project.
- E. Contractor shall not be entitled to an adjustment in Contract Price or Contract Times for delays within the control of Contractor. Delays attributable to and within the control of a Subcontractor or Supplier shall be deemed to be delays within the control of Contractor.

ARTICLE 13 – TESTS AND INSPECTIONS; CORRECTION, REMOVAL OR ACCEPTANCE OF DEFECTIVE WORK

13.01 Notice of Defects

A. Prompt notice of all defective Work of which Owner or Engineer has actual knowledge will be given to Contractor. All defective Work may be rejected, corrected, or accepted as provided in this Article 13.

13.02 Access to Work

A. Owner, Engineer, their consultants and other presental as and personnel of Owner, independent testing laboratories, and governmental agencies with jurisdictional interests will have access to the Site and the Work at reasonable times for their observation, inspecting, and testing. Contractor shall provide them proper and safe conditions for such access and advise them of Contractor's Site a fety procedures and programs so that they may comply therewith as applicable.

13.03 Tests and Inspections

- A. Contractor shall give Expineer chely nedce of readiness of the Work for all required inspections, tests, or approach and shall cooperate with inspection and testing personnel to facilitate required a poction or tests.
- B. Owner may en loy and pay for the services of an independent testing laboratory to perform all inspections, test or approvals required by the Contract Documents except:
 - 1. for inspections, teles, or approvals covered by Paragraphs 13.03.C and 13.03.D below;
 - 2. that costs incurred in connection with tests or inspections conducted pursuant to Paragraph 13.04.B shall be paid as provided in said Paragraph 13.04.C; and
 - 3. as otherwise specifically provided in the Contract Documents.
- C. If Laws or Regulations of any public body having jurisdiction require any Work (or part thereof) specifically to be inspected, tested, or approved by an employee or other representative of such public body, Contractor shall assume full responsibility for

- arranging and obtaining such inspections, tests, or approvals and furnish Engineer the required certificates of inspection or approval. Owner shall pay any inspection fee imposed by the public body.
- D. Contractor shall be responsible for arranging and obtaining and shall pay all costs in connection with any inspections, tests, or approvals required for Owner's and Engineer's acceptance of materials or equipment to be incorporated in the Work; or acceptance of materials, mix designs, or equipment submitted for approval prior to Contractor's purchase thereof for incorporation in the Work. Such inspections, tests, or approvals shall be performed by organizations acceptable to Owner and Engineer.
- E. If any Work (or the work of others) that is to be inspected, tested, or approved is covered by Contractor without written concurrence of Engineer, it must, if requested by Engineer, be uncovered for observation.
- F. Uncovering Work as provided in Paragraph 13.03. Fishall be at Contractor's expense unless Contractor has given Engineer timely notice. Sontractor's intention to cover the same and Engineer has not acted with reasonable properties in response to such notice.
- G. No observations, inspections, tests, or approval by Engineer, Owner, or others shall relieve Contractor of its obligation to perform the Work in accordance with the Contract Documents.

13.04 Uncovering Work

- A. If any Work is covered contary to the watten request of Engineer, it must, if requested by Engineer, be uncovered a Engineer's observation and replaced at Contractor's expense.
- B. If Engineer considers it necessary or advisable that covered Work be observed by Engineer or inspected tested by others, Contractor, at Engineer's request, shall uncover, expose or other se make available for observation, inspection, or testing as Engineer may require, that ortion of the Work in question, furnishing all necessary labor, material, and equipment.
- C. If it is found that the uncovered Work is defective, Contractor shall pay all claims, costs, losses, and damages (including but not limited to all fees and charges of engineers, architects, attorneys, and other professionals and all court or arbitration or other dispute resolution costs) arising out of or relating to such uncovering, exposure, observation, inspection, and testing, and of satisfactory replacement or reconstruction (including but not limited to all costs of repair or replacement of work of others); and Owner shall be entitled to an appropriate decrease in the Contract Price. If the parties are unable to agree as to the amount thereof, Owner may make a Claim therefor as provided in Paragraph 10.05.

D. If, the uncovered Work is not found to be defective, Contractor shall be allowed an increase in the Contract Price or an extension of the Contract Times, or both, directly attributable to such uncovering, exposure, observation, inspection, testing, replacement, and reconstruction. If the parties are unable to agree as to the amount or extent thereof, Contractor may make a Claim therefor as provided in Paragraph 10.05.

13.05 Owner May Stop the Work

A. If the Work is defective, or Contractor fails to supply sufficient skilled workers or suitable materials or equipment, or fails to perform the Work in such a way that the completed Work will conform to the Contract Documents, Owner may order Contractor to stop the Work, or any portion thereof, until the cause for such order has been eliminated; however, this right of Owner to stop the Work shall not give rise to any duty on the part of Owner to exercise this right for the benefit of Contractor, any Subcontractor, any Supplier, any other individual or entity, or any surety for or employee or agent of any of them.

13.06 Correction or Removal of Defective Work

- A. Promptly after receipt of written notice, Contractor shall correct all defective Work, whether or not fabricated, installed, or concleter or, if the Work has been rejected by Engineer, remove it from the Project and recace it with Work that is not defective. Contractor shall pay all claims, cost chasses, an damages (including but not limited to all fees and charges of engineers, an hiteen attorneys, and other professionals and all court or arbitration or other dispute resolution costs) arising out of or relating to such correction or removal (including out not limited to all costs of repair or replacement of work of others).
- B. When correcting defective that under the terms of this Paragraph 13.06 or Paragraph 13.07, Contractor that we no ction that would void or otherwise impair Owner's special warranty and grarantee, if my, or said Work.

13.07 Correction Period

- A. If within one year after the date of Substantial Completion (or such longer period of time as may be prescribed by the Contract Documents) any Work is found to be defective, or if the repair of any damages to the land or areas made available for Contractor's use by Owner or permitted by Laws and Regulations as contemplated in Paragraph 6.11.A is found to be defective, Contractor shall promptly, without cost to Owner and in accordance with Owner's written instructions:
 - 1. repair such defective land or areas; or
 - 2. correct such defective Work; or

- 3. if the defective Work has been rejected by Owner, remove it from the Project and replace it with Work that is not defective, and
- 4. satisfactorily correct or repair or remove and replace any damage to other Work, to the work of others or other land or areas resulting therefrom.
- B. If Contractor does not promptly comply with the terms of Owner's written instructions, or in an emergency where delay would cause serious risk of loss or damage, Owner may have the defective Work corrected or repaired or may have the rejected Work removed and replaced. All claims, costs, losses, and damages (including but not limited to all fees and charges of engineers, architects, attorneys, and other professionals and all court or arbitration or other dispute resolution costs) arising out of or relating to such correction or repair or such removal and replacement (including but not limited to all costs of repair or replacement of work of others) will be paid by Contractor.
- C. In special circumstances where a particular item of Auipment is placed in continuous service before Substantial Completion of all the Work, he correction period for that item may start to run from an earlier date if so provided in the specifications.
- D. Where defective Work (and damage to the Work restring therefrom) has been corrected or removed and replaced under his Faragraph 13.07, the correction period hereunder with respect to such Work will be extended for an additional period of one year after such correction or removal and the lacement as been satisfactorily completed.
- E. Contractor's obligations under this Par are in 15.37 are in addition to any other obligation or warranty. The provisions of the Para, aph 13.07 shall not be construed as a substitute for or a waiver of the provisions of any applicable statute of limitation or repose.

13.08 Acceptance of Defective Work

A. If, instead of recurring control or removal and replacement of defective Work, Owner (and, prior to Entineer's recommendation of final payment, Engineer) prefers to accept it, Owner may do so. Sontractor shall pay all claims, costs, losses, and damages (including but not limited to all feet and charges of engineers, architects, attorneys, and other professionals and all court or arbitration or other dispute resolution costs) attributable to Owner's evaluation of and determination to accept such defective Work (such costs to be approved by Engineer as to reasonableness) and the diminished value of the Work to the extent not otherwise paid by Contractor pursuant to this sentence. If any such acceptance occurs prior to Engineer's recommendation of final payment, a Change Order will be issued incorporating the necessary revisions in the Contract Documents with respect to the Work, and Owner shall be entitled to an appropriate decrease in the Contract Price, reflecting the diminished value of Work so accepted. If the acceptance occurs after such recommendation, an appropriate amount will be paid by Contractor to Owner or Owner may offset an appropriate amount from final payment if not yet paid. If

the parties are unable to agree as to the amount thereof, Owner may make a Claim therefor as provided in Paragraph 10.05.

13.09 Owner May Correct Defective Work

- A. If Contractor fails within a reasonable time after written notice from Engineer to correct defective Work or to remove and replace rejected Work as required by Engineer in accordance with Paragraph 13.06.A, or if Contractor fails to perform the Work in accordance with the Contract Documents, or if Contractor fails to comply with any other provision of the Contract Documents, Owner may, after seven days written notice to Contractor, correct or remedy any such deficiency.
- B. In exercising the rights and remedies under this Paragraph 13.09, Owner shall proceed expeditiously. In connection with such corrective or remedial action, Owner may exclude Contractor from all or part of the Site, take possession of all or part of the Work and suspend Contractor's services related thereto, take possession of Contractor's tools, appliances, construction equipment and machiner at the Site, and incorporate in the Work all materials and equipment stored at the Site of for which Owner has paid Contractor but which are stored elsewhere Contractor hall allow Owner, Owner's representatives, agents and employees, Owner's other contractors, and Engineer and Engineer's consultants access to the Site of the Site of the rights and remedies under this Paragraph.
- C. All claims, costs, losses, and damages (the ding but not limited to all fees and charges of engineers, architects, attorneys, and offer professionals and all court or arbitration or other dispute resolution costs) in turred or sustained by Owner in exercising the rights and remedies under this Paragraph 13-19 will be charged against Contractor, and a Change Order will be is used in the contracting the necessary revisions in the Contract Documents with respect to be Work; and Owner shall be entitled to an appropriate decrease in the Contract Price of the parties are unable to agree as to the amount of the adjustment, Owner may noke a Claim therefor as provided in Paragraph 10.05. Such claims, costs, losses and demages will include but not be limited to all costs of repair, or replacement of work of others destroyed or damaged by correction, removal, or replacement of Contract as defective Work.
- D. Contractor shall not be allowed an extension of the Contract Times because of any delay in the performance of the Work attributable to the exercise by Owner of Owner's rights and remedies under this Paragraph 13.09.

ARTICLE 14 - PAYMENTS TO CONTRACTOR AND COMPLETION

14.01 Schedule of Values

A. The Schedule of Values established as provided in Paragraph 2.05 will serve as the basis for progress payments and will be incorporated into a form of Application for Payment acceptable to Engineer. Progress payments on account of Unit Price Work will be based on the number of units completed.

14.02 Progress Payments

A. Applications for Payments

- 1. At intervals of once a month, Contractor shall submit to Engineer for review an Application for Payment filled out and signed by Contractor covering the Work completed to the first day of such month and accompanied by such supporting documentation as is required by the Contract Dayments. If payment is requested for materials and equipment not incorporated in the Liork but delivered and suitably stored at the Site or at another location agreed to writing, the Application for Payment shall also be accompanied by soill of sale, invoke, or other documentation warranting that Owner has received the materials and equipment free and clear of all Liens and evidence that the materials are equipment are covered by appropriate property insurance or other arrangements to protect Owner's interest therein, all of which must be satisfactory to Owner.
- 2. Each Application for Popular to Start be accompanied by completed and legally effective releases or yeavers satisfactory to Owner) of all Lien rights arising out of or Liens filed in connection with the Work, to the date of the Application for Payment. Applications for progress asyments shall be accompanied by a Conditional Release of Lien substantially conficuring to the form specified in California Civil Code section 3262. Confactor may use the form attached hereto as Exhibit P.
- 3. Beginning with the second Application for Payment, each Application shall include an affidavit of Connect stating that all previous progress payments received on account of the Work have been applied on account to discharge Contractor's legitimate obligations associated with prior Applications for Payment. Such affidavit shall substantially conform to the form attached as Exhibit Q. It shall be Contractor's responsibility to maintain the property free of all liens from subcontractors retained or employed by Contractor upon submitting an Application for Payment covering such subcontractor's work and an affidavit attesting that such payment has been applied to such Subcontractor's account.
- 4. The amount of retainage with respect to progress payments will be as stipulated in the Agreement.

B. Review of Applications

- Engineer will, within 10 days after receipt of each Application for Payment, either indicate in writing a recommendation of payment and present the Application to Owner or return the Application to Contractor indicating in writing Engineer's reasons for refusing to recommend payment. In the latter case, Contractor may make the necessary corrections and resubmit the Application.
- 2. Engineer's recommendation of any payment requested in an Application for Payment will constitute a representation by Engineer to Owner, based on Engineer's observations on the Site of the executed Work as an experienced and qualified design professional and on Engineer's review of the Application for Payment and the accompanying data and schedules, that to the best of Engineer's knowledge, information and belief:
 - a. the Work has progressed to the point indicate
 - b. the quality of the Work is generally in accordance with the Contract Documents (subject to an evaluation of the Work as a functioning whole prior to or upon Substantial Completion, to the results of any subsequent tests called for in the Contract Documents, to a final determination of quantities and classifications for Unit Price Work under Paragraph 9.5 and to any other qualifications stated in the recommendation); and
 - c. the conditions precedent to Contractor being entitled to such payment appear to have been fulfilled in to fall its it is Engineer's responsibility to observe the Work.
- 3. By recommending any control payment Engineer will not thereby be deemed to have represented that:
 - a. inspect as made to check the quality or the quantity of the Work as it has been performed have been exhaustive, extended to every aspect of the Work in progress, a volved detailed inspections of the Work beyond the responsibilities specifically assigned to Engineer in the Contract Documents; or
 - there are no other matters or issues between the parties that might entitle Contractor to be paid additionally by Owner or entitle Owner to withhold payment to Contractor.
- 4. Neither Engineer's nor Owner's review of Contractor's Work for the purposes of recommending payments or determining to make payments, nor Engineer's recommendation of any payment, including final payment, nor Owner's decision to

make any payment, including final payment, will impose responsibility on Engineer or Owner:

- a. to supervise, direct, or control the Work, or
- b. for the means, methods, techniques, sequences, or procedures of construction, or the safety precautions and programs incident thereto, or
- c. for Contractor's failure to comply with Laws and Regulations applicable to Contractor's performance of the Work, or
- d. to make any examination to ascertain how or for what purposes Contractor has used the moneys paid on account of the Contract Price, or
- e. to determine that title to any of the Work, materials, or equipment has passed to Owner free and clear of any Liens.
- 5. Engineer may refuse to recommend the whole of any part of any payment if, in Engineer's opinion, it would be incorrected make the representations to Owner stated in Paragraph 14.02.B.2. Engineer may also refuse to recommend any such payment or, because of subsequent v discovered evidence or the results of subsequent inspections or tests, have or revoke any such payment recommendation previously made to such a tent as may be necessary in Engineer's opinion to protect Owner from los because:
 - a. the Work is defection or completed Work has been damaged, requiring correction or replacement
 - b. the Contract Price of Jeen reduced by Change Orders;
 - c. Owner has corrected efective Work or completed Work in accordance with Paraginah 13.09;
 - d. Engineer has a dal knowledge of the occurrence of any of the events enumerated in aragraph 15.02.A.

C. Payment Becomes Due

- Thirty days after presentation of the Application for Payment to Owner with Engineer's recommendation, the amount recommended will (subject to the provisions of Paragraph 14.02.D) become due, and when due will be paid by Owner to Contractor.
- D. Reduction in Payment

- Owner may refuse to make payment of the full amount recommended by Engineer because:
 - a. claims have been made against Owner on account of Contractor's performance or furnishing of the Work;
 - Liens have been filed in connection with the Work, except where Contractor has delivered a specific bond satisfactory to Owner to secure the satisfaction and discharge of such Liens;
 - c. there are other items entitling Owner to a set-off against the amount recommended; or
 - d. Owner has actual knowledge of the occurrence of any of the events enumerated in Paragraphs 14.02.B.5.a through 14.02.B.5.c or Paragraph 15.02.A.
- 2. If Owner refuses to make payment of the full account recommended by Engineer, Owner will give Contractor immediate written actice with a copy to Engineer) stating the reasons for such action and promptly prof Contract cany amount remaining after deduction of the amount so withheld owner shall promptly pay Contractor the amount so withheld, or any adjustment there agreed to by Owner and Contractor, when Contractor remedies the reasons for act action.
- 3. Upon a subsequent determination that Swner refusal of payment was not justified, the amount wrongfully withheld still be treated as an amount due as determined by Paragraph 14.02.C.1 and the light treated as provided in the Agreement.

14.03 Contractor's Warranty of The

A. Contractor warrant and gurantees that title to all Work, materials, and equipment covered by any application for syment, whether incorporated in the Project or not, will pass to Owner's e and clear of all liens no later than the time of payment.

14.04 Substantial Completion

- A. When Contractor considers the entire Work ready for its intended use Contractor shall notify Owner and Engineer in writing that the entire Work is substantially complete (except for items specifically listed by Contractor as incomplete) and request that Engineer issue a certificate of Substantial Completion.
- B. Promptly after Contractor's notification, Owner, Contractor, and Engineer shall make an inspection of the Work to determine the status of completion. If Engineer does not consider the Work substantially complete, Engineer will notify Contractor in writing giving the reasons therefor.

- C. If Engineer considers the Work substantially complete, Engineer will deliver to Owner a tentative certificate of Substantial Completion which shall fix the date of Substantial Completion. There shall be attached to the certificate a tentative list of items to be completed or corrected before final payment. Owner shall have seven days after receipt of the tentative certificate during which to make written objection to Engineer as to any provisions of the certificate or attached list. If, after considering such objections, Engineer concludes that the Work is not substantially complete, Engineer will within 14 days after submission of the tentative certificate to Owner notify Contractor in writing, stating the reasons therefor. If, after consideration of Owner's objections, Engineer considers the Work substantially complete, Engineer will within said 14 days execute and deliver to Owner and Contractor a definitive certificate of Substantial Completion (with a revised tentative list of items to be completed or corrected) reflecting such changes from the tentative certificate as Engineer believes justified after consideration of any objections from Owner.
- D. At the time of delivery of the tentative certificate of Stastantial Completion, Engineer will deliver to Owner and Contractor a written accommendation as to division of responsibilities pending final payment between Owner and Contractor with respect to security, operation, safety, and protection the Work, caintenance, heat, utilities, insurance, and warranties and guarantees. Unless Owner and Contractor agree otherwise in writing and so inform Engineer in writing prior to Engineer's issuing the definitive certificate of Substantial Completion, angineer's aforesaid recommendation will be binding on Owner and Contractor that final payment.
- E. Owner shall have the right to exclude Contractor from the Site after the date of Substantial Completion subject to allowing Contractor reasonable access to remove its property and complete or correct tems on the tentative list.

14.05 Partial Utilization

- A. Prior to Substantial Completion of all the Work, Owner may use or occupy any substantially completed part of the Work which has specifically been identified in the Contract Document or which Owner, Engineer, and Contractor agree constitutes a separately functioning and usable part of the Work that can be used by Owner for its intended purpose without significant interference with Contractor's performance of the remainder of the Work, subject to the following conditions.
 - Owner at any time may request Contractor in writing to permit Owner to use or occupy any such part of the Work which Owner believes to be ready for its intended use and substantially complete. If and when Contractor agrees that such part of the Work is substantially complete, Contractor, Owner and Engineer will follow the procedures of paragraph 14.04 A.-D. for that part of the Work.

- Contractor at any time may notify Owner and Engineer in writing that Contractor considers any such part of the Work ready for its intended use and substantially complete and request Engineer to issue a certificate of Substantial Completion for that part of the Work.
- 3. Within a reasonable time after either such request, Owner, Contractor, and Engineer shall make an inspection of that part of the Work to determine its status of completion. If Engineer does not consider that part of the Work to be substantially complete, Engineer will notify Owner and Contractor in writing giving the reasons therefor. If Engineer considers that part of the Work to be substantially complete, the provisions of Paragraph 14.04 will apply with respect to certification of Substantial Completion of that part of the Work and the division of responsibility in respect thereof and access thereto.
- 4. No use or occupancy or separate operation of part of the Work may occur prior to compliance with the requirements of Paragraph 5 or regarding property insurance.

14.06 Final Inspection

A. Upon written notice from Contractor that the entire Work or an agreed portion thereof is complete, Engineer will promptly make a fix kinst ection with Owner and Contractor and will notify Contractor in writing of all particular in which this inspection reveals that the Work is incomplete or defective. Contractor shall smediately take such measures as are necessary to complete such Work or smediately take such measures as are

14.07 Final Payment

A. Application for Payment

- 1. After Contractor as, in the opinion of Engineer, satisfactorily completed all corrections centified uring the final inspection and has delivered, in accordance with the Contract Documents, all maintenance and operating instructions, schedules, guarantees, ands, critificates or other evidence of insurance, certificates of inspection, marks the record documents (as provided in Paragraph 6.12), and other documents, Contractor may make application for final payment following the procedure for progress payments.
- 2. The final Application for Payment shall be accompanied (except as previously delivered) by:
 - a. all documentation called for in the Contract Documents, including but not limited to the evidence of insurance required by Paragraph 5.04.B.6;
 - b. consent of the surety, if any, to final payment;

- c. a list of all Claims against Owner that Contractor believes are unsettled; and
- d. complete and legally effective releases or waivers (satisfactory to Owner) of all Lien rights arising out of or Liens filed in connection with the Work.
- 3. The Application for Final Payment shall be accompanied by a Release of Lien completed by Contractor, Subcontractors and Suppliers substantially conforming to the form specified in California Civil Code section 3262. Contractor, Subcontractors, or Suppliers may use the form attached hereto as Exhibit R.
- 4. Contractor shall defend, indemnify, and hold Owner harmless against any Lien filed in connection with the Work by any Subcontractor, Supplier, or other lien claimant. At Owner's request, Contractor shall furnish a bond or other collateral satisfactory to Owner to protect and indemnify Owner against any Lien.

B. Engineer's Review of Application and Acceptance

1. If, on the basis of Engineer's observation of the Work during construction and final e final A dication for Payment and inspection, and Engineer's review of accompanying documentation as required by the Contract Documents, Engineer is satisfied that the Work has been comparted and Contractor's other obligations under the Contract Documents have been full d, Engineer will, within ten days after receipt of the final Application for Payment, indicate in writing Engineer's recommendation of payment and present the application for Payment to Owner for payment. At the same time Engler will also give written notice to Owner and cepta e subject to the provisions of Paragraph 14.09. Contractor that the Work Otherwise, Engineer ııl retu the Application for Payment to Contractor, indicating in writing the reason for to recommend final payment, in which case Contractor shall make necessary corrections and resubmit the Application for Payment.

C. Payment Become Due

1. Thirty days after the presentation to Owner of the Application for Payment and accompanying documentation, the amount recommended by Engineer, less any sum Owner is entitled to set off against Engineer's recommendation, including but not limited to liquidated damages, will become due and will be paid by Owner to Contractor.

14.08 Final Completion Delayed

A. If, through no fault of Contractor, final completion of the Work is significantly delayed, and if Engineer so confirms, Owner shall, upon receipt of Contractor's final Application for Payment (for Work fully completed and accepted) and recommendation of Engineer, and without terminating the Contract, make payment of the balance due for that portion of the Work fully completed and accepted. If the remaining balance to be held by Owner for Work not fully completed or corrected is less than the retainage stipulated in the Agreement, and if bonds have been furnished as required in Paragraph 5.01, the written consent of the surety to the payment of the balance due for that portion of the Work fully completed and accepted shall be submitted by Contractor to Engineer with the Application for such payment. Such payment shall be made under the terms and conditions governing final payment, except that it shall not constitute a waiver of Claims.

14.09 Waiver of Claims

- A. The making and acceptance of final payment will constitute:
 - 1. a waiver of all Claims by Owner against Contractor, except Claims arising from unsettled Liens, from defective Work appearing after final inspection pursuant to Paragraph 14.06, from failure to comply with the Contract Documents or the terms of any special guarantees specified therein, or from contractor's continuing obligations under the Contract Documents; and
 - 2. a waiver of all Claims by Contractor around Owner and a release of all liens other than those previously made in accordance with the requirements herein and expressly acknowledged by Owner in writing as still unsettled.

ARTICLE 15 - SUSPENSION OF WORK AN TENTINATION

15.01 Owner May Suspend Work

A. At any time and without cluse, Comes may suspend the Work or any portion thereof for a period of not more than suconsecutive days by notice in writing to Contractor and Engineer which without a day on which Work will be resumed. Contractor shall resume the Work on the Late so had. Contractor shall be granted an adjustment in the Contract Price or an extension of the Contract Times, or both, directly attributable to any such suspension if Contractor makes a Claim therefor as provided in Paragraph 10.05.

15.02 Owner May Terminate for Cause

- A. The occurrence of any one or more of the following events will justify termination for cause:
 - Contractor's persistent failure to perform the Work in accordance with the Contract Documents (including, but not limited to, failure to supply sufficient skilled workers or suitable materials or equipment or failure to adhere to the Progress Schedule established under Paragraph 2.05 as adjusted from time to time pursuant to Paragraph 6.04);

- 2. Contractor's disregard of Laws or Regulations of any public body having jurisdiction;
- 3. Contractor's repeated disregard of the authority of Engineer; or
- 4. Contractor's violation in any substantial way of any provisions of the Contract Documents.
- B. If one or more of the events identified in Paragraph 15.02.A occur, Owner may, after giving Contractor (and surety) seven days written notice of its intent to terminate the services of Contractor:
 - 1. exclude Contractor from the Site, and take possession of the Work and of all Contractor's tools, appliances, construction equipment, and machinery at the Site, and use the same to the full extent they could be used by Contractor (without liability to Contractor for trespass or conversion),
 - 2. incorporate in the Work all materials and equipment stored at the Site or for which Owner has paid Contractor but which are stored elsewhere, and
 - 3. complete the Work as Owner may deem expedient.
- C. If Owner proceeds as provided in Paragraph 17 J2.B, Contractor shall not be entitled to receive any further payment until the Work is ampleted. If the unpaid balance of the Contract Price exceeds all claims, costs, asses, and damages (including but not limited to all fees and charges of engineers, a chitcais, itorneys, and other professionals and all court or arbitration or other digrate restration costs) sustained by Owner arising out of or relating to completing the Work, such excess will be paid to Contractor. If such claims, costs, losses, and damages exceed such unpaid balance, Contractor shall pay the difference to Owner. Such pairs, costs, losses, and damages incurred by Owner will be reviewed by Engineer, to their reasonableness and, when so approved by Engineer, incorporated in a Change Orde. When exercising any rights or remedies under this Paragraph Owne shall not be required to obtain the lowest price for the Work performed.
- D. Notwithstanding Paragrans 15.02.B and 15.02.C, Contractor's services will not be terminated if Contractor begins within seven days of receipt of notice of intent to terminate to correct its failure to perform and proceeds diligently to cure such failure within no more than 30 days of receipt of said notice.
- E. Where Contractor's services have been so terminated by Owner, the termination will not affect any rights or remedies of Owner against Contractor then existing or which may thereafter accrue. Any retention or payment of moneys due Contractor by Owner will not release Contractor from liability.

F. If and to the extent that Contractor has provided a performance bond under the provisions of Paragraph 5.01.A, the termination procedures of that bond shall supersede the provisions of Paragraphs 15.02.B and 15.02.C.

15.03 Owner May Terminate For Convenience

- A. Upon seven days written notice to Contractor and Engineer, Owner may, without cause and without prejudice to any other right or remedy of Owner, terminate the Contract. In such case, Contractor shall be paid for (without duplication of any items):
 - completed and acceptable Work executed in accordance with the Contract Documents prior to the effective date of termination, including fair and reasonable sums for overhead and profit on such Work;
 - 2. expenses sustained prior to the effective date of termination in performing services and furnishing labor, materials, or equipment as required by the Contract Documents in connection with uncompleted Work, plus fair and reasonable sums for overhead and profit on such expenses;
 - 3. all claims, costs, losses, and damage (including but not limited to all fees and charges of engineers, architects, attorn vs, and other professionals and all court or arbitration or other dispute resolution constitution of terminated contracts with Subcontractors, Sanstiers, and others; and
 - 4. reasonable expenses directly attributable to rmination.
- B. Contractor shall not be pair on a count of loss of anticipated profits or revenue or other economic loss arising out of or resulting from such termination.

15.04 Contractor May Stop or Teminate

- A. If, through no st or fault of Contractor, (i) the Work is suspended for more than 90 consecutive days we Owne or under an order of court or other public authority, or (ii) Engineer fails to act to any Application for Payment within 30 days after it is submitted, or (iii) Owner fails for any days to pay Contractor any sum finally determined to be due, then Contractor may, upon seven days written notice to Owner and Engineer, and provided Owner or Engineer do not remedy such suspension or failure within that time, terminate the Contract and recover from Owner payment on the same terms as provided in Paragraph 15.03.
- B. In lieu of terminating the Contract and without prejudice to any other right or remedy, if Engineer has failed to act on an Application for Payment within 30 days after it is submitted, or Owner has failed for 30 days to pay Contractor any sum finally determined to be due, Contractor may, seven days after written notice to Owner and Engineer, stop the Work until payment is made of all such amounts due Contractor, including interest

thereon. The provisions of this Paragraph 15.04 are not intended to preclude Contractor from making a Claim under Paragraph 10.05 for an adjustment in Contract Price or Contract Times or otherwise for expenses or damage directly attributable to Contractor's stopping the Work as permitted by this Paragraph.

ARTICLE 16 – DISPUTE RESOLUTION

16.01 Methods and Procedures

- A. At any time after submitting notice of a claim under Paragraph 10.05.A and prior to the expiration of the 30-day time period set forth in Paragraph 10.05.D, Owner or Contractor may give to the other party written notice of intent to submit the Claim to a process of bilateral negotiations as set forth below.
- B. Within 30 days of delivery of such notice, Owner and Contractor shall meet and confer regarding the Claim. A good-faith effort to negotiate esolution shall be made by both parties.
- C. If the negotiations contemplated by Paragraph 16.01.B ar unsuccessful, management representatives of Owner and Contractor at east one tier above the individuals who met under 16.01.B shall meet, confer, and ne stiate within 30 days of the closure of the unsuccessful negotiations.
- D. If the Claim is not resolved by negot tion, the Claim shall be deemed denied and shall become final and binding 30 days after terminal in of the negotiations unless, within that time period, Claimant:
 - 1. invokes the dispute solution process provided for in Paragraph 16.01.E, or
 - 2. agrees with the part to submit the Claim to another dispute resolution process.
- E. Mandatory Non hinding Menation. If a dispute arises out of, or relates to this Agreement, or the breach the sof, and if said dispute cannot be settled through normal contract negotiations, the Paries agree to first endeavor to settle the dispute in an amicable manner, using mandatory non-binding mediation under the Construction Industry Mediation Rules of the American Arbitration Association before having recourse in a court of law. The expenses of witnesses for either side shall be paid by the party producing such witnesses. All other expenses of the mediation, including required travel and other expenses of the mediator, and the cost of any proofs or expert advice produced at the direct request of the mediator, shall be borne equally by the Parties, unless they agree otherwise. Any resultant agreements from mediation shall be documented in writing. All mediation proceedings, results, and documentation shall be inadmissible for any purpose in any legal proceeding (pursuant to California Evidence Codes sections 1115 thru 1128), unless such admission is otherwise agreed upon in writing by both parties. Mediators

- shall not be subject to any subpoena or liability, and their actions shall not be subject to discovery.
- F. Any dispute arising under the Contract not resolved through mediation shall be resolved through submittal of the dispute to a court of competent jurisdiction.
- G. Covenant of Good Faith and Fair Dealing:
 - This contract imposes an obligation of good faith and fair dealing in its performance and enforcement. The Contractor, Engineer and Owner, with a positive commitment to honesty and integrity, agree to the following mutual duties:
 - a. Each will function within the laws and statues applicable to their duties and responsibilities.
 - b. Each will assist in the other's performance
 - c. Each will avoid hindering the other's personance.
 - d. Each will proceed to fulfill its obligations dilignatly.
 - e. Each will cooperate in the commo endeavor of the contract.

ARTICLE 17 – MISCELLANEOUS

17.01 Giving Notice

- A. Whenever any provision of the Contract D currents requires the giving of written notice, it will be deemed to have beginning the contract D currents requires the giving of written notice, it will be deemed to have beginning the contract D currents requires the giving of written notice,

 - 2. delivered at or sent v resistered or certified mail, postage prepaid, to the last business accress know to the giver of the notice, or by facsimile transmission.

17.02 Computation of Times

A. When any period of time is referred to in the Contract Documents by days, it will be computed to exclude the first and include the last day of such period. If the last day of any such period falls on a Saturday or Sunday or on a day made a legal holiday by the law of the applicable jurisdiction, such day will be omitted from the computation.

17.03 Cumulative Remedies

A. The duties and obligations imposed by these General Conditions and the rights and remedies available hereunder to the parties hereto are in addition to, and are not to be construed in any way as a limitation of, any rights and remedies available to any or all of

them which are otherwise imposed or available by Laws or Regulations, by special warranty or guarantee, or by other provisions of the Contract Documents. The provisions of this Paragraph will be as effective as if repeated specifically in the Contract Documents in connection with each particular duty, obligation, right, and remedy to which they apply.

17.04 Survival of Obligations



Such insurance shall include appropriate clauses pursuant to which the insurance companies shall waive its rights of subrogation against Owner and Company.

Contractor and subcontractors shall furnish prior to the start of work, certificates or adequate proof of the foregoing insurance including, if specifically requested by Company, copies of the endorsements and insurance policies naming Owner and Company as an Additional Insured. Current certificates of insurance shall be provided prior to the commencement of work and be maintained until completion of the contract. Owner shall be notified in writing at least thirty (30) days prior to cancellation of or material change in a policy. Carriers providing coverage will be rated by A.M. Best with at least an A- rating and a financial size category of at least Class VII. Such cancellation or material alteration shall not relieve

Contractor of its continuing obligation to maintain insurance coverage in accordance with this contract.

(B) If Contractor shall fail to procure and maintain said insurance, Owner or Company, upon written notice, may, but shall not be required to, procure and maintain same, but at the expense of Contractor. In the alternative, Owner or Company may declare a default hereunder and, unless such default is timely cured, terminate the Lease. Unless and until the default is cured, neither Contractor nor its servants, employees or agents will be allowed to enter upon the Premises.
