Dear Ms. Indersoll:

This will serve to acknowledge receipt of your letters dated February 10 and 24, 2006, inviting the District to make a presentation to the Seaside City Council at its March 9, 2006 (6:00 p.m.) study session on water issues. We're pleased that you have offered the District an opportunity to brief the Seaside City Council on the District's water supply project that will benefit your City.

Based on the phone call I made to you recently, it's my understanding that you are asking the District to make a presentation on its proposed Aquifer Storage and Recovery (ASR) Phase 1 project, the injection/recovery wells for which are proposed to be located in the vicinity of Gen. Jim Moore Boulevard. I will make some introductory remarks, followed by a Powerpoint presentation on the ASR Phase 1 project by our District Project Manager, Henrietta Stern. The Powerpoint presentation will be an updated version of the one District staff made in the District's Town Hall meeting at Embassy Suites last August, including the specific information you requested in your letters. The District is undertaking this ASR Phase 1 project in partnership with California American Water. Because I understand you've sent him a similar project presentation request, I'm copying this letter to Cal Am's Coastal Division Manager, Steve Leonard with the suggestion that his engineer working with us on the ASR project and Henrietta coordinate on details of the respective presentations. I've asked Henrietta to send you our final Powerpoint presentation by March 6.

I wish to make the following comments on Action Items 15 & 17 :

Item 15: Any agreement with Cal-Am to facilitate present and future aquifer storage and recovery projects must recognize the District's primary authority under its legislative mandate to protect the resource. This cannot be subject to negotiation. Cal-Am's current citation for overdraft is only the latest in a long history of violations. The current uncertain status of future ownership only increases the importance of District control.

Item 17: The logical representative to the Watermaster Board is Fran Farina. She not only has the requisite legal and technical background but as importantly, a complete knowledge of the history and operational requirements of the District. We need the strongest available presence on this board and it is Fran.

The League of Women Voters of the Monterey Peninsula supports the District's authority to make findings regarding the availability, quantity, and quality of water for future development within its area or "sphere of influence." Any agreement with CalAm to facilitate present and future Seaside aquifer storage and recovery project operations must insure the District's primary authority, under its legislative mandate, to protect the resource.

We believe the District's legislative mandate supercedes the questions of individual water rights, and we urge the Board to take the necessary action to protect the mandate given to it by the State of California.

CONDITION 8 OF PERMITS 7130B AND 20808 (APPLICATIONS 11674B AND 27614), CARMEL RIVER IN MONTEREY COUNTY

In your December 8, 2005 letter, you seek information regarding the status of Condition 8 of Permits 7130B and 20808. Condition 8 requires the following: "Construction work shall be prosecuted with reasonable diligence and shall be completed by December 31, 2005."

The Monterey Peninsula Water Management District (District) has filed Change Petitions for the two permits for purposes of (a) implementing direct diversion of 7,909 acre-feet per annum from the Carmel River, and (b) implementing the Seaside Groundwater Basin Aquifer Storage and Recovery Project. The petitions requested that 33 of the 53 permit conditions be deleted, including Condition 8. In the listing of permit terms that the District asks to have deleted, the District noted that Condition 8 was not applicable for the petitions. The Division of Water Rights (Division) noticed the change petitions for the two projects. The project descriptions do not include any discussion of District requests for time extension, because the Division has not received time extension petitions from the District.

If the District requires time extensions for the permits, it must file petitions for extension of time. In order to grant time extension, the Division must find that the requirements of title 23, California Code of Regulations section 844 have been met.

Section 844:

An extension of time within which to complete an application, to commence or complete construction work or apply water to full beneficial use will be granted only upon such conditions as the board determines to be in the public interest and upon a showing to the board's satisfaction that due diligence has been exercised, that failure to comply with previous time requirements has been occasioned by obstacles which could not reasonably be avoided, and that satisfactory progress will be made if an extension of time is granted. Lack of finances, occupation with other work, physical disability, and other conditions incident to the person and not to the enterprise will not generally be accepted as good cause for delay. The board may, in its discretion, require a hearing upon notice to the permittee and such other parties as the board may prescribe.




The District's December 8 letter indicates that deletion of the permit condition would be consistent with the State Water Resources Control Board's current practice to no longer include construction deadlines as conditions in its water right permits. Although new permits do not have a permit condition regarding completion of construction, the District's permits contain the condition. The Division's only administrative procedure for modifying existing permit terms is the petition process.
