Board Requests Charge to Ad-Hoc Subcommittee

 July 18, 2011 WaterPlus presentation re: analysis of cost to purchase Cal-Am
 Directors request staff develop draft charge for ad-hoc subcommittee that would:

- Analyze cost for public ownership of Cal-Am's Monterey District
- Describe governance for a publicly owned utility
- Define utility's scope of responsibility
- Do not recommend support or disapproval



## Draft Charge to Public Ownership Analysis Committee (POAC)

Meet for six months, November 2011 through April 2012

- Meetings open to public in compliance with Brown Act
- Present report to Board in May 2012
  Utilize as reference, but not be limited to:
  - WaterPlus July 7, 2011 proposal for public acquisition of Cal-Am
  - Beacon Valuation Group, LLC 2005 report on Cal-Am's fair market value



### Draft Charge to Public Ownership Analysis Committee (POAC)

Report will address the following:

- Cost to purchase Cal-Am's Monterey District
- Timeline to complete eminent domain process
- Cost cap ratepayers would accept over defined time period
- Cal-Am's contractual obligations that would transfer to publicly owned utility
- Governance structure
- Public utility's scope of responsibility
- Impacts to Regional Water Project



# Membership on POAC

# POAC comprised of 9 members

- -7 community members
  - Each director appoints one member. Must reside within the District and represent a community group
- 1 representative from Cal-Am
- 1 representative from WaterPlus
- MPWMD General Manager non-voting chair
- District staff provides support



# Committee Member Selection Process

# Determine Community Interest in Serving on POAC

- Option 1
  - Directors contact representatives from list of community groups shown as Exhibit 15-B

#### – Option 2

- Send letter to community groups (Exhibit 15-C) along with questionnaire (Exhibit 15-D) to identify organizations that would like to participate
- Each director may select a representative from the list of organizations that have indicated an interest in participation on the committee



# Committee Member Selection Process

# Alternatives for Committee Membership

- Option B -- 9 member committee
  - 2 directors, 5 community members appointed by directors that are not seated on committee, 1 rep. from Cal-Am, and 1 rep. from Water Plus

#### - Option C -- 16 member committee

 14 appointees (each director appoints 2 members), 1 rep. from Cal-Am and 1 rep. from Water Plus

- Option D - concepts developed by Board
