Budget, Cost Sharing for Coming Year

First, preparing an annual budget for the MPRWA in totally unlike preparing a municipal budget, where you have precedents and multi-year experience. All figures are truly estimates, based on the anticipated work program/expenses of the coming year.

Local attorney legal services retainer was discussed at the June 14, 2012 meeting, but use of a participating agency attorney is presently being discussed.

Participation in the costs of the MPRWA could be done on a "weighted" basis as is set forth in the JPA for an alternate voting procedure, as follows:

Section 8 of the JPA agreement is regard to voting, states (in part): "one vote for each Director, unless one or more Directors request weighted voting. If weighted voting is requested, then each Director's vote shall be weighted proportionally to the amount of water delivered to Cal-Am customers within each City, as determined on a three year running average....."

The latest figures available, calculated in January 2012, as applied to this budget amount would be, for each participating jurisdiction:

A related matter on your agenda is the reconsideration of a proper formula for weighting.

Depending on what happens in the forthcoming year, it is possible that this budget will have to be further adjusted.

Perhaps the most significant point is that the MPRWA has a major task as set forth in the JPA agreement, and cannot accomplish this task without adequate resources available to it.
