MPWMD Rule 162

- Rule 162 specifies the regulatory water production targets that are used in the MPWMD *Expanded Water Conservation and Standby Rationing Plan*.
- Tables XV-1 and XV-2 of Rule 162 specify monthly and year-to-date at month-end production targets for all Cal-Am sources within the MPWRS and Laguna Seca Subarea, respectively.
- Rule 162 requires that modifications to Tables XV-1 and XV-2 be made by Board Resolution.

Cal-Am Regulatory Production Constraints

- State Water Resources Control Board (SWRCB) Cease and Desist Order (CDO) -- issued October 20, 2009.
- Seaside Basin Adjudication – Amended Decision issued February 9, 2007.

Cal-Am Regulatory Production Targets

- For WY 2013, CDO specifies annual limit of:
 - **10,187 AF** from Carmel River sources.
- For WY 2013, Seaside Basin Adjudication specifies annual limits of:
 - **2,669 AF** for Coastal Subareas;
 - **147 AF** for Laguna Seca Subarea.
- For WY 2013, combined limits of:
 - **13,003 AF** for all MPWRS sources.

NOTE: Limits do not include Seaside Basin carryover credits.
