I have included an estimated budget for the workshop planning and facilitation. I have also included references for relevant projects.

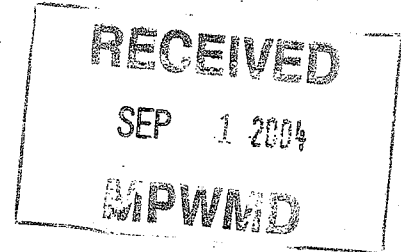

Proposed Scope:

This budget is for coordination and facilitation services. Apex Strategies would:

- Consult with individual Chair and individual Board members on their desires and expectations for Strategic Plan workshop outcomes (up to 4 hours);
- Work with General Manager and key staff on technical information needed for workshop as determined by client (up to 3 hours assumes a lot by phone);
