#### 1. CALL TO ORDER/ROLL CALL

MEMBERS PRESENT: Lance Monosoff, Thomas House, Larry Levine, Majorie Ingram

Viales, Vincent Frumkin, and Lorin Letendre

MEMBERS ABSENT: Frank Pierce

PUBLIC PRESENT: Roy Kaminske, Lynn Cellars, and Margaret Robbins

STAFF PRESENT: Larry Hampson, Thomas Christensen, and Kevan Urquhart

- 2. PUBLIC COMMENT Roy Kaminske stated that a series of small dams and weirs on the Carmel River would help solve the water supply problem on the Carmel River.
- 3. CONSENT CALENDAR Larry Levine made a motion to approve the minutes from the October 29, 2015 Regular Meeting, and was seconded by Thomas House. **The minutes were approved by a unanimous vote.**
- 4. UPDATE AND DISCUSSION ON CARMEL RIVER WATERSHED CONSERVANCY ACTIVITIES Lorin Letendre stated the CRWC has installed signs stating that drivers are entering the Carmel River Watershed on Carmel Valley Road and Laureles Grade. He also stated that student watershed tours will start in the spring. The CRWC has also prioritized 42 actions in the watershed. The top five include: 1) increase off stream storage, 2) steelhead barrier removal, 3) add large woody debris to the Carmel River, 4) the Carmel River Floodplain Restoration and Environmental Enhancement Project, and 5) spawning gravel augmentation. The CRWC is also working with Trout Unlimited to remove fish passage barriers.

#### 5. STAFF REPORTS –

A. Monterey Peninsula Water Supply Projects – Larry Hampson stated that Pure Water Monterey has moved into the permit application phase and that there is a draft water purchase agreement between Monterey Regional Water Pollution Control Agency, MPWMD, and Cal-Am.

Larry Hampson also stated Cal-Am is still testing their slant wells that would be used to pull in seawater for desalination for the Monterey Peninsula Water Supply Project.

With regards to the Deep Water Desal Project, Larry Hampson stated Deep Water Desal is working on the EIR with the State Lands Commission.

B. Update on Current Rainfall and Flow Conditions - Thomas Christensen stated that

rainfall to date was 130% of average with a current total at San Clemente of 14.30 inches.

- C. Update on Los Padres Dam Long-Term Plan Larry Hampson stated there is \$1 million for a long-term plan for Los Padres Dam and that it will look at upstream passage and sediment management. It is possible that a stakeholder group will help decide the future of Los Padres Dam.
- D. Update on San Clemente Dam Removal and Reroute Project Staff showed photos of the removal of San Clemente Dam and the associated step pools. In addition, staff explained that the old Carmel River dam will be removed in the summer of 2016.
