At its May 21, 2007 public meeting, the Board of the Monterey Peninsula Water Management District (MPWMD or District) approved a fee increase for Water Distribution System (WDS) permit Pre-Applications and Applications to reflect actual costs experienced by the District.

In essence, the fee charged when a Pre-Application or Application Form is submitted is a "deposit" – additional fees will be charged before permit issuance if actual expenses exceed the initial fee amount. Expenses may include MPWMD consultant help, legal review or County of Monterey filing fees. Importantly, refunds will be issued (or Pre-Application savings can be applied to the Application phase) if actual costs are less than the initial fee. There is no change to the MPWMD staff rate; it remains at \$70 per hour.
