#### **Action Items**

1. Adopt Minutes of February 1, March 1, and April 5, 2011 Technical Advisory Committee meetings

On a motion by O'Halloran and second of Conroy, the minutes were adopted unanimously on a vote of 6-0. Bodensteiner and Greer were absent.

2. Consider Recommendation to the Board of Directors on First Reading of an Ordinance Amending the Rebate Program

On a motion by Hardgrave and second of Matarazzo, the committee voted to recommend that the Board of Directors adopt the ordinance as presented by staff and outlined in the committee packet. The motion was adopted unanimously on a vote of 7-0. Greer was absent.

### **Discussion Items**

3. Review Upcoming August 25, 2011 Board Workshop on Alternative Water Supply Planning

Fuerst reported that the workshop will cover progress on alternative water supplies proposed by the District such as desalination, and aquifer storage and recovery. Projects proposed by the Monterey Regional Water Pollution Control Agency will also be reviewed, such as groundwater replenishment and the Regional Urban Water Augmentation Project. The discussion will focus on a timeline for completion of these projects in relation to completion of the Regional Water Project.

4. Discuss Plan to Conduct Joint Meeting of the Policy and Technical Advisory Committees on September 13, 2011

The purpose of this meeting will be to review information brought forward at the August 25, 2011 Board Workshop, and discuss conclusions reached based on that information.

# **Oral Report**

5. Update on Implementation of CDO Moratorium

Laredo reported that settlement discussions and mediation sessions had been conducted but a settlement had not been reached. A case management conference was scheduled for August 23, 2011. More information would be provided at the September 13, 2011 joint meeting of the Policy and Technical Advisory committees.
