## ORDINANCE NO. 17

AN ORDINANCE OF THE BOARD OF DIRECTORS OF THE MONTERY PENINSULA WATER MANAGEMENT DISTRICT EXEMPTING CERTAIN WATER SYSTEMS FROM ORDINANCE NO. 16

WHEREAS, the provisions of Ordinance No. 16, adopted as an urgency measure on August 13, 1984 were intended as an interim measure to facilitate a full evaluative and planning effort with respect to the contemplated revision of the MPWMD expansion (connection) permit rules, and

WHEREAS, the Board of Directors has expressed its intent to revise the connection charge and water supply improvement charge only with respect to water distribution systems which would derive a benefit from the proposed new sources of supply which would be the end product of those charges, and

WHEREAS, The Board of Directors has received the analysis of its staff, and of expert consultants, and based on that analysis at this time perceives that the following water distribution systems will not receive a substantial benefit from the proposed new sources of supply,

NOW, THEREFORE, BE IT ORDAINED THAT,

1. Notwithstanding the provisions of Ordinance No. 16, adopted as an urgency measure at the regular meeting of the Board of Directors held on August 13, 1984, the provisions of Rules 22 through 28, inclusive of the Monterey Peninsula Water Management District shall continue in full force and effect, without suspension of administrative review, for the following water distribution systems:
