### **Integrated Regional Water Management**

- Monterey Peninsula planning region eligible for up to \$4.33 million in Proposition 1 IRWM grant funds
- The Department of Water Resources (DWR) awarded \$466,000 in 2018 for Disadvantaged Community planning
- \$1.9 million available to the region in 2019
- \$2.0 million to be awarded in 2020
- Comprehensive proposal submitted to DWR for each round of funding
- Proposal for the current round of funding due in the fall of 2019



## **Project Solicitation**

- Four implementation projects submitted for consideration:
  - Del Monte Manor Park Low Impact Development (LID) Improvements Project, City of Seaside, \$560,000
  - Ramona Avenue Stormwater Runoff Infiltration Project, City of Monterey, \$338,000
  - West End Stormwater Management Improvements, Sand City, \$2.6 million
  - Coe Avenue Recycled Water Distribution
    Pipeline, Marina Coast Water District, \$605,000



**Regional Water Management Group** recommended funding

- Del Monte Manor Park Low Impact Development (LID) Improvements Project, City of Seaside, \$560,000 (100%)
- Ramona Avenue Stormwater Runoff Infiltration
  Project, City of Monterey, \$338,000 (100%)
- West End Stormwater Management Improvements, Sand City, \$677,000 (26%)
- Coe Avenue Recycled Water Distribution
  Pipeline, Marina Coast Water District, \$325,000 (50%)



### **DUDEK Proposal**

- Meet with each project proponent
- Develop and provide templates for consistent format and in compliance with DWR proposal requirements
- Provide project analysis
- Assist with required DWR workshop
- Follow up on project proposal



## Recommendations

Recommendation 1:

Enter into an agreement with Dudek to provide services to prepare and submit a comprehensive grant proposal to the Department of Water Resources for a Not-to-Exceed cost of \$95,600 with a contingency of \$4,400 for unforeseen expenses.

#### Recommendation 2:

Obtain a reimbursement agreement with Marina Coast Water District for expenses associated with including the Coe Avenue Recycled Water Distribution Pipeline project in a grant application.
