Item: Consideration of Approval of a Water Distribution System Permit for a

Replacement Well to irrigate the recreation fields at Carmel Middle School in

Carmel Valley.

The Monterey Peninsula Water Management District's Administrative Hearing Officer will consider Application #WDS-20220119CAR submitted on February 10, 2022, by the Carmel Unified School District for a Water Distribution System Permit (WDS) at the Carmel Middle School for a Replacement Well to irrigate the recreation fields on four Parcels, 015-162-028-000, 015-162-029-000, 015-162-014-000, 015-162-015-000. System Limits are proposed to be set at 37 acre-feet annually which reflects the historical average. The Replacement Well was approved by Monterey County Environmental Health Bureau and was drilled in 2021 to replace a failed irrigation Well that had been used since 1962.

MPWMD staff recommends approval of the application with Conditions of Approval that comply with the minimum standards specified in MPWMD Rule 22-C, based on evidence in the record, and the mandatory conditions required in Rule 22-D. The complete information package for this public hearing, including Findings and Conditions of Approval, will be available for review on the District's website no later than April 1, 2022. If you are unable to participate at the hearing, written comments should be received at the District office no later than 3:00 PM on April 5, 2022.
