



NOTICE OF INTENT TO ADOPT INITIAL STUDY/NEGATIVE DECLARATION

- 1. PROJECT TITLE:** Approval of a Water Distribution System Permit for a Replacement Well for irrigation at the Carmel Middle School.
- 2. DESCRIPTION AND LOCATION OF PROJECT:** The project site is located at 4380 Carmel Valley Road, Carmel. The project is Consideration of Approval of a Water Distribution System Permit for a Replacement Well to irrigate the recreation fields at Carmel Middle School in Carmel Valley. The permit will set a pumping limit of 37 acre-feet annually on the well, which reflects the historical average. The replacement well was approved by Monterey County Environmental Health Bureau and was drilled in 2021 to replace a failed irrigation Well that had been used since 1962.
- 3. REVIEW PERIOD:** The Review Period is March 1, 2022, through March 31, 2022.

DISCUSSION OF CHECKLIST ITEMS: No items were checked: The Carmel Middle School (CMS) has historically used an Alluvial Well¹ to irrigate the recreational fields at the school. The property was transferred to the Carmel Unified School District from Louise Hatton in 1961, and the water rights transferred at that time have remained intact. The original Well constructed circa 1962 failed in 2015, and the irrigation system was temporarily supplied by the potable California-American Water Connection that serves the school and the landscape around the buildings. A Replacement Well was approved by the Monterey County Environmental Health in 2020, and a new Well was drilled in 2021. The Monterey Peninsula Water Management District requires an approved Water Distribution System Permit with pumping limits to be set prior to use of the Replacement Well.

The Production Limit shall be 37 Acre-Feet Annually, which is the average of reliable annual metered usage over six years. Unfortunately, additional reliable data is not available due to issues with previous meters on the Well. It is known that the Well has been regularly used at this production level for irrigation of the fields, and that the irrigation fluctuates depending on the sports needs of the students and athletic programs. Use at this level is supported by the fact that there are approximately 19 acres of grasses and vegetables (including the MEarth outdoor classroom) under irrigation.

The historic use of Well water for irrigation on this Site supports the continued use of the CMS Water Distribution System and approval of the Replacement Well as the Source of Supply with a limit of 37 Acre-Feet Annually.

Conclusion

Based on this Initial Study, the MPWMD believes that there is an absence of substantial evidence from which a fair argument can be made that approval of a Water Distribution System Permit for a Replacement Well at Carmel Middle School has meaningful actual or potential adverse environmental consequences. MPWMD believes that approval of this Permit would have less than significant environmental impacts. MPWMD is aware that CEQA requires preparation of a negative declaration if there is no substantial evidence that the project may cause a significant effect on the environment (CEQA Guidelines §15063(b)(2).) For these reasons, MPWMD intends to adopt a negative declaration regarding approval of a Water Distribution System Permit for a Replacement Well for Camel Middle School.
