CALIFORNIA AMERICAN WATER QUARTERLY WATER SUPPLY BUDGET: July – September 2017



- Consistent with SWRCB Orders 95-10, 98-04, 2002-02, and 2016-0016, Seaside Groundwater Basin adjudication decision, and District Rule 162 targets.
- Assumes Water Projects 1 & 2 (ASR) will produce 300 AF/month to meet demand this Quarter (2,345 AF was diverted to storage through May 31 of Water Year 2017).
- Includes annual reductions for 2016 in Carmel River System diversions per Order WR 2016-0016, and the triennial reductions in 2015 from the Seaside Basin per the adjudication.



CALIFORNIA AMERICAN WATER QUARTERLY WATER SUPPLY BUDGET: July – September 2017

- Assumes full utilization of all legally available native Seaside Basin groundwater during Water Year 2017.
- Assumes production of as much of the ASR storage made to date in WY 2017, as is physically feasible in this Water Year. The remaining ASR storage from WY 2017 will be allocated in WY 2018
- Developed cooperatively by MPWMD, Cal-Am, California state Department of Fish and Wildlife (CDFW), and the National Marine Fisheries Service (NMFS), on June 08, 2017. Other invited agencies attending were the State Water Resources Control Board.

Recommendation
