



12. Discussion on SB 1157 (Hertzberg)

- In 2018, the California legislature passed and Governor Brown signed Assembly Bill 1668 (Friedman) and Senate Bill 606 (Hertzberg). This bill created a new framework for setting customized Urban Water Use Objectives
- Establishes standards and practices for the following water uses:
 - (A) Indoor residential use.
 - (B) Outdoor residential use.
 - (C) CII water use.
 - (D) Water losses.
 - (E) Other unique local uses and situations that can have a material effect on an urban water supplier's total water use.
- Beginning next year actual annual use will be reported compared to UWUO
- SB 1157 changes the standards for indoor residential water use beginning January 1, 2025, to 47 gallons per capita daily (gpcd) & 42 gpcd January 1, 2030
- Monterey Peninsula total indoor & outdoor residential use is 48 gpcd

Population Change in Monterey County - It's Generally Going Down

The California Department of Finance announced its annual population estimates yesterday (May 2, 2022) for counties, cities, and the state. For the second year in a row, the population of California declined.

However, the decline has slowed. It went down 0.3 percent between January 1, 2021 and January 1, 2022, while it went down 0.59 percent between April 1, 2021 (the date of the U.S. Census) and December 31, 2021.
