- What can we do better?




Board Responsibility

- Common vision, mission, and community focus
- Collegial, respectful, professional, collaborative and cooperative
- Mindful about decision-making and long-term impacts
- Understand and appreciate differences of opinions and viewpoints





What is a "Goal"?



- Direction of the organization
- Consistent with mission, vision, and values
- Typically, qualitative and capable to embrace multiple objectives
- May be near-term and/or longer-term



What is an "Objective"?


 A roadmap directing the organization how to reach each Goal

More specific and measurable than the Goal itself





- Be a regional leader on water issues, raise profile, instill public trust... (2023, 2022, 2021, 2019)



Resource Management Issues

- Continue strategic planning for near-term & long-term water supply... (2023, 2022, 2021)
- Develop strategy for water permit 20808 ... (2019)
- Develop long-term strategy for Los Padres Dam... (2019)
- Prepare for allocation of "new water" (2019)
- Look at new direction for Carmel River mitigation program (2023, 2019)




Administrative Function Issues
