Better define organizational requirements & costs for "integrated" operations (Cal-Am employees join MPWMD)

Receive pro forma operating agreement, costs, and risk allocation for 3rd party operations; Look at water system and desal plant separately


Extension of Existing Contract

Sole Source Contract to 1 or 2 Operators

Explore joint operations with existing public entity (e.g. Monterey One Water)



LAFCO Process: Mis-matched Boundaries

LAFCO: Cal-Am Main System Outside of MPWMD

Adjust MPWMD boundaries to better match the Cal-Am Main System
