Action Items

Consider Adoption of July 2, 2020 Committee Meeting Minutes

On a motion by Riley and second of Hoffmann, minutes of the July 2, 2020 committee meeting were adopted on a unanimous vote of 3 - 0 by Riley, Hoffmann and Edwards.

Discussion Items

Update on Water for Near-Term Housing Needs Initiative

Stoldt presented the PowerPoint viewed by the Policy Advisory Committee on August 4, 2020. He responded to questions from the committee. Directors comments were as follows. (a) The allocation numbers presented were sufficient, the District should move ahead without modifications. (b) Concern expressed that the Carmel River was overdrafted. The SWRCB allowed California-American Water to exceed the legal water right, and this proposal would be yet another request to exceed allowable diversions and continue ongoing damage to the Carmel River resources. (c) If this effort was not successful, suggest that pressure be placed on the SWRCB to answer questions regarding Condition 2 of the Cease and Desist Order (CDO).

Stoldt made the following statements in response to questions from the committee. A permanent water supply could be developed within 30 months, and the proposed 75 acre-feet allocation was more than could be used by the jurisdictions in that time based on the pre-2009 growth rates of approximately 16 acre-feet per year. Water production was 3,600 acre-feet below that recorded in 2009. The District would not be requesting that the effective diversion limit be raised. The request to the SWRCB would be to recognize that water production was above the effective diversion limit, but nevertheless, due to health and safety concerns the District would propose to utilize 2% of the conservation savings achieved for housing until a water project is complete. Counsel Laredo stated that the District must exhaust all administrative remedies before it could take legal steps to obtain action from the SWRCB on Condition 2 of the CDO. If the SWRCB did approve the request, it would likely impose a myriad of conditions specifying the types of projects the water could be allocated to.

Public Comment: (1) Ande Flower, Principal Planner for the City of Monterey, thanked the Water Demand Committee and staff for expressing solidarity with the City to be a frontrunner in development of affordable housing for the region. She stated that based on her discussions with developers and architects, the City of Monterey could use most or all of the anticipated allocation. She urged the District to request that the SWRCB allow the donation of water credits from property owners to the City for meaningful allocation. (2) John Tilley requested that a hydrologic analysis be conducted to show that this proposal would not decrease Carmel River streamflow. He stated the District's reliance on the SWRCB to grant the community an increase in water production signaled that the agency was not doing its job of providing a long-term sustainable water supply and protecting water resources. He urged the District to support development of the Cal-Am desalination project. (3) Kim Cole, Community Development Director for the City of Monterey, reported that the City Council had identified sites for 100% affordable housing projects. She expressed support for the District's effort to exhaust discussions with the SWRCB regarding Condition No. 2. (4) Luke Coletti asked a series of questions: if the proposal is approved, who would be the gatekeeper of the new allocation; who would determine the meaning of "affordable" housing project; and how would Condition 2 apply to projects that would be identified as not affordable.

SUMMARY: Staff has long been aware of the significant amount of time it often takes for federally funded projects to receive appropriations to begin construction. Recent conversations with representatives of both the Presidio of Monterey and the Naval Postgraduate School resulted in requests for a future Allocation of water and consideration of extending the length of time a Water Use Credit is available on these installations. Both facilities are located in the City of Monterey, which has no water available for military projects.

Separate water Allocations for the Presidio and the Naval Postgraduate School (including its housing area and recreation facility) make sense when new water supply is available. However, in the interim, one or both entities may need water for projects, many of which have been planned and approved, but have not received funding. The Presidio undertook a number of retrofit projects in the early 2000's in anticipation of receiving funding, and those credits have expired. They are currently about to lose the remaining credits when they expire in 2021.

The shortage of space at the Presidio often results in the untimely demolition of buildings after construction of new ones, resulting in a post-project credit that can't be applied to a previous project. Staff, faculty, and students must wait for construction of the new building before vacating the old one for demolition. No demolition, no water credit, no water credit, no construction, no demolition...etc. The opposite is also true where buildings are demolished to make space for new construction that is dependent on federal funding that may not come through.

The success of the Presidio's mission to train military linguists depends on their ability to modernize and expand their training facilities. In order to do this, the Presidio needs to have sufficient water available to offset their projects so that they can comply with District law when a project moves forward. Until the moratorium is lifted, one concept to address this is to extend Water Use Credits at the Presidio and the Naval Postgraduate School Sites for an additional ten years, making the credit available for a total of 20 years.

A similar consideration was given to Redevelopment Agency Sites when the Board adopted Ordinance No. 121 on August 15, 2005, to extend credit for Redevelopment Projects for up to 20 years. Staff's preliminary estimate of an extension to the two military Sites would extend/reinstate up to 40 acre-feet of Water Use Credits.

RECOMMENDATION: The Water Demand Committee should discuss this item and provide direction to staff.

SUMMARY: Water Use Credits are documented when (1) there is a Permanent Abandonment of Use, or (2) following the installation of Ultra-Low Water Use Technology not required by the District, or (3) when there is a temporary removal of a use, such as a Change of Use¹. The credit process (Rule 25.5) allows the reuse of the reduced increment of water on the same Site. Credit may be transferred to other Sites pursuant to Rule 28. Water Use Credits resulting from a Permanent Abandonment of Use (i.e., demolition or permanent removal of plumbing or fixtures, or replacement of fixtures with state-of-the-art equipment or high efficiency appliance credits) allow the reuse of the reduced increment of water on a Site for up to ten years.

Recent discussions about extending credit for the Presidio of Monterey and the Naval Postgraduate School raised the question about extending all Water Use Credits. Staff preliminarily believes that an insignificant extension (e.g. for no more than one year) that must be approved administratively within the year prior to expiration would have no measurable impact on the environment.

RECOMMENDATION: Staff recommends the Water Demand Committee discuss the possibility of extending a Water Use Credit.

5. UPDATE ON ACTIVITIES RELATED TO NON-CAL-AM PUMPERS ON THE CARMEL RIVER

SUMMARY: Water use from the Carmel Valley Alluvial Aquifer (CVAA) directly impacts the flow of the Carmel River, including the health of the steelhead trout and California red-legged frogs. As California American Water (Cal-Am) reduces its demand on the system, it would be prudent for the District to look at ways to reduce pumping from non-Cal-Am Wells in the CVAA.

All water Users¹ within the District are subject to the water efficiency standards of Regulation XIV and Regulation XV, including retrofit upon resale requirements, Well metering, and prohibitions on Water Waste. Well Users within the CVAA are also subject to permitting requirements that include establishment of production limits and reductions in those limits when converting from agricultural use to other types of use.

There are 387 Wells in the CVAA, with 68 reporting no use.

At its May 7, 2020 meeting, the Water Demand Committee began discussion about potential programs to reduce water use from non-Cal-Am producers in the CVAA, including:

- 1. Requiring Water Meters (and reporting requirements) on all CVAA Wells;
- 2. Target CVAA Well Users with outreach, such as:
 - a. Residential/Domestic Use: Rebate program and availability of free conservation devices, water-wise landscape concepts;
 - b. Irrigation Only: Promote use of Automatic Irrigation Controllers and efficient irrigation practices, including availability of rebates and resources. Workshops/training on efficient irrigation. Review permit requirements for agricultural irrigation, including how water rights may preclude or affect efficiency requirements.

Looking more at the data since the May 2020 meeting, staff examined the potential efficacy of the proposals.

Requiring Water Meters:

There are 90 un-metered wells, but only 78 reported any use. Of those, only 21 reported use greater than 1.0 acre-feet annually (AFA) (2017 data) and only eight were over 2.0 AFA. The highest unmetered use was 3.54 AFA.

Mandating water meters for the 78 active wells or even the top 8 users, is unlikely to yield significant savings compared to the cost. Further, current District policy requires installation of water meters when the land transfers ownership.

Targeted Outreach:

The table below shows all wells in the Carmel Valley Alluvial Aquifer that utilize greater than 3.0 AFA. A blank space under "Entity" means it is an individual or family-owned. Note that several entities have more than one well in the table. There may be opportunities for targeted outreach, however each entity may have differing needs or requirements. Additional research to determine what types of uses occur on each parcel will help inform the likelihood of successful targeted outreach.
